Thank you for taking the first step to transform our publicly owned land at Sharp Park from an exclusive, underused, and budget-breaking golf course into a community-centered model for endangered species recovery, natural flood control, outdoor recreation, and sustainable land use.

I strongly support Supervisor Mirkarimi's proposed ordinance to transfer Sharp Park to the National Park Service as part of the Golden Gate National Recreation Area or to jointly manage the park with the Park Service. The ordinance would also require the city's Recreation and Parks Department to develop a plan, schedule, and budget for restoring Sharp Park habitat for endangered species on the site, a welcome change from the mismanagement of recent years. I urge the city and county of San Francisco to restore Sharp Park as a coastal lagoon and wetland habitat for endangered species. Please follow through by passing this important legislation.

Sharp Park Golf Course has a long history of environmental problems because of its poor design and unfortunate placement on a coastal lagoon. The course has had problems with flooding and drainage ever since opening, and the Department has created new and significant environmental impacts. The current operation of the golf course harms wetland habitat and causes illegal take of two federally listed species, the California red-legged frog and the San Francisco garter snake.

The golf course is a significant money-loser for San Francisco that makes no sense to maintain at a time when the city has cut the Recreation and Parks Department staff and the long-term golf prospects at the site are slim. Combine that with the problems with endangered species, wetland destruction, flooding, and sea-level rise, and it is clear that restoration of Sharp Park to a natural state is the best option for the area.

Ecological restoration is the most fiscally responsible method of managing Sharp Park and dealing with flood management issues at the site. Compared to the costs of implementing capital improvements necessary to maintain the golf course combined with the high potential for massive civil penalties for harming endangered species, restoration alternatives seem to be the most fiscally prudent method for retaining recreational uses of the area.

San Francisco's 2004 recreational study shows that the number-one recreational demand in San Francisco is more hiking and biking trails -- and golf came in 16th. San Francisco already has six public golf courses, and about 50 other golf courses are within a 45-minute drive of Sharp Park. Restoring Sharp Park will help meet recreational demand through hiking and biking trails, picnicking spots, camping facilities, a world-class nature center, a gateway to the San Mateo County Golden Gate National Recreation Area lands, and educational opportunities sorely needed in San Mateo County. Restoration will also ensure the continued existence and abundance of endangered species at Sharp Park.

Please transfer Sharp Park to the National Park Service or jointly manage the property with the Service to restore Sharp Park as a coastal lagoon and wetland habitat for endangered species.





The purpose of this memo is to provide information regarding the changes being recommended to the Health Care Accountability Ordinance (HCAO). This item (File #09-0130) was introduced to the Board on February 3, 2009 and is scheduled to be heard by the Budget & Finance Committee on April 8, 2009.

HCAO Background

The HCAO represents one of San Francisco's early, pioneering efforts to reduce the number of uninsured in San Francisco. HCAO went into effect on July 1, 2001. It requires that employers doing business with the City offer health insurance coverage meeting Minimum Standards determined by the Health Commission. As an alternative to offering health insurance, employers may pay an in-lieu fee to the Department of Public Health (DPH) to offset costs of health care provided to the uninsured.

While the Health Commission is authorized to set the Minimum Standards, changes to the employer fee must be approved by the Board of Supervisors. The Minimum Standards were revised twice since the Ordinance took effect, once in 2004 and again in 2008. The employer in-lieu fee, which started out as \$1.50 per hour, was changed once in 2006 (to \$2/hour).

Recommended Changes to HCAO

The Board of Supervisors is being asked to review and approve three changes to the HCAO. They include:

1. An increase to the employer in-lieu fee from \$2/hour (maximum \$80 per week) to \$2.80/hour (maximum \$112 per week).
2. Allow the in-lieu fee to be automatically updated based on DPH recommendations (relying on certain parameters) to the Controller's Office on an annual basis.
3. Change the definition of covered employee under the Ordinance from working 15 hours or more per week to 20 hours or more per week.

HCAO Minimum Standards Work-Group

As has been DPH's practice since 2001, DPH convened a group of stakeholders to review the Minimum Standards and other issues related to the Ordinance. The group's first meeting was in July, 2008 and continued through September (6 meetings total). The following organizations were represented by one or more individuals at the meetings:

- Community Housing Partnership
- Conard House
- Episcopal Community Services, San Francisco
- Levinson Benefits Group Insurance Services
- Office of Labor Standards & Enforcement (CCSF)
- Richmond Area Multi-Services (RAMS)
- Shargel & Co. Insurance Services
- San Francisco Airport
- San Francisco Church Women United
- San Francisco Health Authority
- San Francisco Human Services Network
- San Francisco Living Wage Coalition
- San Mateo Labor Council
- SEIU Local 1877

The Minimum Standards Work-Group meetings gave individuals from various organizations, perspectives and experience with HCAO an opportunity to review the issues, study the small business health insurance market, and develop consensus on recommendations for change. All of the recommendations coming to the Board now were explored and approved of by the Work-Group members.¹

Employer In-Lieu Fee Increase

When employers subject to HCAO are unable or unwilling to provide health insurance meeting the Minimum Standards, they are required to pay a fee to DPH. It is crucial that employers are not incentivized to pay the fee because a) it is more affordable than health coverage; and/or b) the Minimum Standards are unrealistic. HCAO's Minimum Standards were becoming increasingly difficult for employers to meet, but with changes made effective in November 2008 this is no longer the case. However, the \$2 hourly fee (\$80 maximum per week) paid to DPH no longer corresponds to the reality of health insurance premium costs.

The difficulties in paying for health coverage are felt by all employers, especially smaller businesses and non-profits. Members of the Work-Group representing businesses, like Debbi Lerman from the Human Services Network (representing local non-profits), consistently stressed that employers prefer to provide health insurance over paying a fee. Understandably, employers prefer to offer something tangible to their employees (through coverage) rather than support the overall cost for the City to care for the uninsured. The Work-Group agreed to recommend an increase from \$2 per hour (weekly max of \$80) to \$2.80 (weekly max of \$112). This is based on the increases over the past four years to HMO premiums in California².

¹ The Living Wage Coalition abstained from three votes related to changes to the Minimum Standards (including premium payment increase, including a prescription drug deductible option, and increase in the annual out-of-pocket payment). This does not relate to the HCAO changes at issue in this memo.

Automatic Updates to the In-Lieu Fee

The Ordinance requires that the Board of Supervisors act officially to revise the employer in-lieu fee, through a change to the Ordinance. This process is time-consuming, especially compared to the process for updates to the Minimum Standards. Given the symbiotic relationship between the in-lieu fee and the Minimum Standards, as employers will look at both options when deciding how to comply with HCAO, this is not an ideal scenario. It is important to construct the HCAO in a way that avoids a situation where an employer prefers the in-lieu fee (especially an artificially low one) to offering health coverage. This can be avoided by creating a system that updates the fee in a quick and efficient manner, on an annual basis.

In an ideal scenario, the employer will make decisions based on accurate information. As the process works now, there may be a long period of time (many months) where the Minimum Standards are newly updated and the in-lieu of fee is outdated but on the cusp of change. This was the case for employers who renewed health coverage plans in late 2008 for the coming year. The changes to the Minimum Standards were effective in early November. Around this same time, the Health Commission approved the recommended changes to the in-lieu fee, but revisions were not introduced to the Board until February. As of the date on this memo, the item has not yet gone to Committee. Therefore, employers making a decision for the coming year had imperfect information. It is not impossible to imagine an employer choosing to pay the in-lieu fee because it was still set at \$2/hour rather than pay for health coverage. This does not benefit the employee (who does not get health insurance), nor does it benefit the employer (who may soon see the fee increase 40%).

Over the past four years, health insurance premiums have increased an average of 10 percent per year. Waiting a few years to make these changes creates a situation where the in-lieu fee jumps significantly, which is more difficult to work into a budget than smaller, annual increases. This will be more difficult to absorb for a business, than a smaller, more frequent increase. The process of changing the fee, which starts at the review and ends at the Board of Supervisors, has been taking up to a year or more. By this time, the new fee is outdated and already on the low end. Making the changes annual and more automatic will provide the employer with more reliable information, make each increase easier to handle for employers who choose to pay the in-lieu fee, and better reflect the ongoing reality of the health insurance premium marketplace.

Changes to Definition of "Covered Employee"

HCAO currently defines "covered employee" as one working 15 or more hours per week. This requirement is problematic because it is at odds with health insurance industry practice and has unintended consequences in relation to the Health Care Security Ordinance (HCSO). The ultimate goal of the HCAO is to increase the number of insured workers in San Francisco. While employers have an option to provide health coverage that meets the Minimum Standards, or to pay the in-lieu of fee, the optimal situation is one where the employer can actually choose between one approach or the other. This is not possible for employers who have employees working 15 to 29 hours per week. Health insurance companies only offer coverage for individuals working 20 or more hours per week. Very part-time workers (15-19 hours/week) cannot be insured, regardless of HCAO's rules or the wishes of the employer.

HCSO and the Healthy San Francisco program create an environment where, for the first time, employees who are uninsured, including those subject to HCAO but without coverage, can enroll in a plan that offers health care access. Healthy San Francisco provides universal, comprehensive, affordable health care to uninsured adults irrespective of the person's income

level, employment status, immigration status or pre-existing medical conditions. HCAO takes precedent over the HCSO, meaning that employers subject to both ordinances must follow the tenants of HCAO first. Currently, for very part-time workers, HCAO requires that the employer pay the in-lieu fee to DPH rather than paying the fee to help the employee join Healthy San Francisco. The employee may enroll in Healthy San Francisco individually, but they are not given the benefit of the employers' payment to the program through HCSO's rules because HCAO has superseded HCSO. This does not benefit the employer or the employee, and has become an unintended consequence of the two ordinances.

Because of this, DPH and the Work-Group recommend that the Board of Supervisors delete from HCAO the requirement to insure 15 to 19 hour per week workers. It would be preferable if these workers could access Healthy San Francisco in a manner similar to other workers not bound by HCAO. By removing very part-time workers from the HCAO, they can fully benefit from Healthy San Francisco and the HCSO, and employers will no longer be required to pay a fee to DPH when they have no option to insure their employee.

In conclusion, DPH recognizes the shared interest in seeing HCAO meet its goals of reducing the numbers of uninsured and thereby enhancing the quality, stability and productivity of the workforce on the City's contracts and leases. We believe that with the Board's support and approval, these changes will significantly improve HCAO's effectiveness.

Subject What I Saw at the Supes Today (4/6/9)

Dear Friends and Neighbors,

I dropped by the supes' Public Safety Committee meeting Monday morning to see what the city's crime busters were up to. It was not a reassuring spectacle.

For one thing, they had trouble mustering a quorum. Chair David Campos was the only supe on hand at 11:00 a.m., when the cameras of SFGTV were ready to roll. Ross Mirkarimi was "en route," said Campos. He didn't say anything about the third member, Michela Alioto-Pier. However, nobody ever expects her to be on time.

The meeting was held in the board's cavernous legislative chamber. The smaller room down the hall was scheduled for another committee at 1:00 p.m., not leaving enough time for the windy proceedings that mark this crew.

I had time to count the light bulbs in the nearly empty cavern. There are 128, divided among eight huge, gilded chandeliers. All the bulbs were burning brightly, and for no purpose. (Is there a metaphor here?)

Finally, about half an hour later, the missing two appeared, and all three were ready for their close-ups. However, there was a glitch. The first item on the agenda was a hearing proposed by Bevan Dufty on the police department's fraud division. However, Campos announced that Dufty had not been able to get his materials together in time, so the matter would be continued.

On to the second and final item. It was to be a presentation by the police department on recent crime, with statistics broken down by districts and neighborhoods. However, Capt. David Lazar announced that the department had not yet been able to break down the data as requested.

So Lazar essentially reintroduced material that he had presented to the committee at a previous meeting. The encouraging news is that most crimes are down, compared to the same period for last year. The disappointing news is that he already told us that once before.

The rest of the meeting was devoted to familiar rhetoric, oft heard before. Said Ross Mirkarimi: "I am concerned about the resolution of unresolved cases. We need better statistics on resolution rates."

Said David Campos: "I am concerned about cutting crime-prevention programs." Michela Alioto-Pier was mostly silent.

Then they adjourned.

The whole scene reminded me of the 1993 flick "Groundhog Day." The characters find they have to repeat a certain day in their lives over and over until they finally get it right.

The difference is that "Groundhog Day" is a Hollywood movie, and so the characters eventually do get it right.

There is no such guarantee in real life.



We know the economy is not at its best right now, but taking away Carli Fullerton and watching this Center go towards privatization is not a viable solution to any budgetary shortfall. San Francisco is the City that knows how. It is supposed to take care of its young and old. Please explore other ways to trim the budget. Voluntary/mandatory furloughs perhaps?? Shorter hours at the Centers? Canvass all senior Rec & Park employees to ascertain upcoming service retirements. You are all very intelligent individuals. Come up with some other solution because shortchanging the kids and the seniors is unconscionable.

FYI, Carli Fullerton has been a City employee longer than what the record reflects. While in high school, she did volunteer work for the Rec & Park Department. That time and dedication must count for something! I invite you to visit the Center just to see what a valuable employee she is.

Thanking you in advance for your consideration.

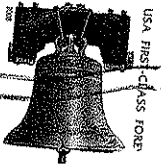

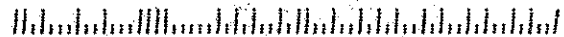

This proposal is being submitted by the SRO Task Force for your consideration for the FY09-10 budget. The San Francisco SRO Task Force, convened originally in 2000 and reconstituted in 2007, is comprised of City department representatives, SRO hotel tenants, service providers, managers, and owners. It advises the Mayor and Board of Supervisors on issues relevant to residents living in SRO Hotels and recommends policies, legislation, and services needed to achieve the following goals:


- Goal 1: San Francisco SRO Hotels are safe, accessible, stable, and 'just' places to live in.
- Goal 2: Affordable, healthy, and appropriate housing options are available in San Francisco so that extremely low-income families do not have to raise their children in SRO Hotels.

The Department of Building Inspection budget submitted to the Mayor's Office is recommending continuation of the \$750,000 allocated to the SRO Collaboratives. The Department of Public Health has recommended annualized reductions of \$357,187 to the Collaboratives as detailed below:

- \$256,176 cut to the Mission, Central City, and Chinatown SRO Collaboratives who serve single, high-at-risk extremely low-income adults living in public and privately-owned SROs will result in tenants receiving NO safety education, improved habitability, medical/mental health, tenant empowerment and stabilization, and community building in SROs.
- \$101,011 cut to the collaborative supporting extremely low-income families with children living in privately-owned SROs will result in the dismantling of this unique program. As many as 500 families, mostly immigrant, families will no longer receive home visits, education, and linkages to improve their environmental health and housing conditions, increase access to social and health services, and increase placement into stable, affordable and more humane living conditions.

The Collaborative model is a low-cost, high impact investment for San Francisco and for our most at-risk and marginalized populations. We urge you to restore the funding for these programs. Thank you in advance for your consideration. Members of the Task Force are available to answer any questions you may have regarding these proposals.

SRO Collaboratives Program Summary:
SRO Tenant Stabilization, Fire Prevention, and Outreach
(April 2009)*

WHAT IS AT STAKE:

The approximately 450 SRO (Single Room Occupancy) hotels in San Francisco represent 18,000 housing units and are the housing of last resort for thousands of extremely low-income people, including over 500 families with over 1,000 children. Originally intended for single working adults, SRO hotels increasingly house adults with special needs and families who have been shut out of the housing market. Some of the SRO's in San Francisco are operated under city contracts with the Department of Public Health and the Human Service Agency. These "City contracted" hotels provide supportive services to the tenants, and the programs are monitored. The private hotels do not have support services on site and some are overcrowded and suffer from dilapidated conditions. SRO tenants are most at risk of homelessness because of a lack of support services. Families with children living in SROs are considered "homeless" under the City's homeless definition. However, they are often overlooked even in the City's plans around homeless services. The Mission, Chinatown, Central City, and SRO Families United Collaboratives were established to address these dire unmet needs. The Collaboratives work closely with the private landlords, managers and tenants to improve conditions for tenants living in the SRO's.

PRIMARY GOAL:

The primary goals of the SRO Collaboratives are to prevent fires, prevent homelessness through eviction prevention and tenant stabilization services, and improve the health and living conditions of tenants, including families with children living in SROs. All of the Collaboratives have also begun to offer Bed Bug eradication services for tenants, and the Mission SRO Collaborative is beginning to provide Disaster Preparedness Education to SRO tenants, in Collaboration with the Red Cross and the Department of Emergency Management.

WHAT WE NEED:

The Collaboratives are pleased to know that the Department of Building Inspection will continue to fund the \$750,000 for vital programs. It is a cost-effective investment that saves the City millions of dollars in saved lives and property, reduced homelessness and emergency service utilization, and increased code and law compliance. The Fiscal Year 09-10 Health Department Budget calls for a \$357,187 cut in funding for the four Collaboratives— \$82,265 for the Mission, \$87,656 for Chinatown, \$86,255 for Central City, and \$101,011 for the Families.

WHAT WE DO:

The programs of the Mission, Chinatown, Central City, and SRO Families United Collaboratives involve a comprehensive approach to SRO hotel fire prevention, community stabilization and peer-to-peer tenant outreach and support. These programs create effective neighborhood partnerships between community-based organizations, SRO tenants, City Departments, and SRO owners and operators in working to preserve and improve this critical stock of very low-income housing.

One of the core programs is fire prevention and education. It is clear that SRO hotel fires are the result of a complex intersection of problems within them: isolation and instability of tenants, lack of education and awareness about fire prevention, code violations and illegal tenancy practices. As a result, the program addresses the critical needs to organize and support tenants, prevent fires and improve conditions, and to coordinate community and public agencies in response to fires and other urgent issues. Also central to the program's approach is the development and involvement of SRO tenant leaders in identifying solutions.

WHO ARE WE:

The Mission SRO Collaborative is a partnership between Dolores Street Community Services (DSCS), St. Peter's Housing Committee (SPHC) and the Mission Neighborhood Resource Center (MNRC). The Chinatown SRO Collaborative is a partnership between Chinatown Community Development Center (CCDC), Chinese Progressive Association (CPA), and the Community Tenants Association. The Central City SRO Collaborative is a partnership between the Tenderloin Housing Clinic, Conard House, and the Mental Health Association. The SRO Families United Collaborative consists of five community-based organizations working in Chinatown/North Beach, Tenderloin, SoMa, and the Mission – they include Chinatown Community Development Center, Chinese Progressive Association, South of Market Community Action Network, Coalition on Homelessness and Dolores Street Community Services.

Each Collaborative has a neighborhood, cultural, and language specific approach. Each agency contributes its particular expertise whether in housing and program development, property management, support services, tenant counseling and housing advocacy, case management and social service provision and/or community organizing and leadership development. Together these agencies contribute established and strong relationships with tenants, landlords, City

agencies, neighborhood organizations, and social service providers. Utilizing the Collaboratives' expertise and experience in SRO hotel stabilization, these programs have been cost-effective and replicable models for other neighborhoods with a large concentration of SRO hotels. The Mission SRO Collaborative was formed in 1996. The Chinatown SRO Collaborative was formed in 2000, and the Central City SRO Collaborative was established in 2001. The SRO Families United Collaborative was founded in 2001.

ACHIEVEMENTS:

1. **SRO Tenant Outreach and Community Stabilization.** The programs involve extensive door-to-door outreach in nearly all of the 450 SRO hotels in San Francisco, distributing thousands of educational and outreach materials. We have provided hundreds of counseling sessions on eviction prevention and support service referrals. We have been leaders in the development, implementation, and enforcement of legislation to protect tenants' rights, including the *Uniform Visitor Policy legislation*.
2. **SRO Fire Safety and Prevention Organizing.** The programs prevent fires in SROs. We partner with the San Francisco Fire Department to conduct fire prevention workshops several times a month in SRO hotels. The Collaboratives were instrumental in the creation of the *Sprinkler Ordinance*, and have played a key role in its implementation.
3. **SRO Hotel Code Enforcement Monitoring and Public Education.** The programs improve conditions in SRO hotels and promote permanent tenancy. The Collaboratives monitor hotel code violations and work with the City Attorney's Code Enforcement Task Force and the SRO Task Force. This has increased the City's capacity to address SRO hotel problems, enforce laws protecting tenants' rights, and promote landlord accountability.
4. **SRO Emergency Planning and Response.** The programs improve coordination among public and community agencies to better prevent and respond to emergencies, especially to those caused by the displacement of tenants after SRO hotel fires. Together with the SRO Health and Safety Task Force, this community-City partnership has greatly improved emergency procedures and strategies.
5. **Technical Assistance to City Agencies and SRO Owners and Operators.** Through one-on-one meetings and group workshops, the Collaboratives assist dozens of privately owned SRO hotels to improve their awareness of laws regulating SRO hotels and mediate conflicts between tenants and management. The Collaboratives work closely with City Agencies to create policies and strategies to improve and stabilize conditions in SROs.
6. **Safe Housing for Families.** The Collaboratives campaign to highlight the issues of families forced to live in crowded SRO hotel rooms. The Collaborative has networked with City departments, community-based organizations, and families living in SRO hotels, creating a citywide collaboration to address this disturbing trend. We conducted the first comprehensive *Census of Families with Children Living in SROs* in 2001, at that time, identifying over 450 families with children living in SROs. That number has continued to grow – for every one family who has been able to move out to more appropriate housing, we have identified two to three new families moving into SROs every year. The SRO Families United Collaborative has provided critical home visits to ensure that isolated families are aware of and assist them in accessing desperately needed services, empowered SRO families to engage in civic participation and impact policies to improve the lives of low-income families, and created a replicable model of community-based outreach, advocacy and collaboration.
7. **SRO Tenant Leadership Development.** The Collaboratives involve SRO tenants in the planning, organizing, and implementation of all programs and campaigns. SRO tenants are employed by the Collaborative as peer advocates, field organizers, and building coordinators.

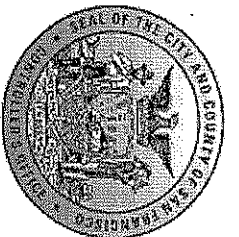

Discussion

In February, San Francisco's unemployment rose to 8.3% on a non-seasonally-adjusted basis. While this does represent an increase of 0.2% from the January figure, both the City's and State's unemployment rose a slower amount than we have seen in the past several months. It is premature to speculate on when unemployment might peak locally, particularly since employment is a lagging economic indicator. Nevertheless, we may be at the end of the sudden downturn that started last fall, and entering a period of more gradual decline.

Since temporary workers are often the first to be laid off during a downturn, and the first to be hired in a recovery, a key jobs indicator to watch is employment in the employment services industry. The monthly drop of 1.5% is still large given the absence of seasonal layoffs in February, and is another reason for continued caution about the state of the local job market.

Other economic indicators are also showing a slowing rate of decline, without yet showing signs of a bottom in key markets. Median housing price is a volatile and imperfect indicator, but it is showing a rebound from January and a slower year-over decline than the previous month. One-bedroom asking rents are also showing slower declines than in recent months past.

In tourism, January was a weak month compared to December, but not nearly as bad as November or October. International arrivals at SFO are now significantly lower than the same month last year, reflecting the global character of the recession and currency weaknesses in key markets, such as Great Britain. The retail picture also shows no sign of recovery yet: the large growth in Saturday BART ridership appears to be due to the timing of the Chinese New Year parade.

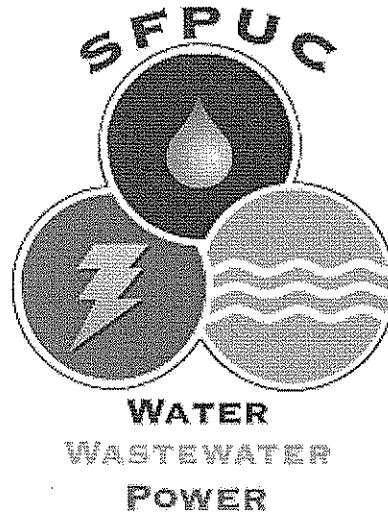

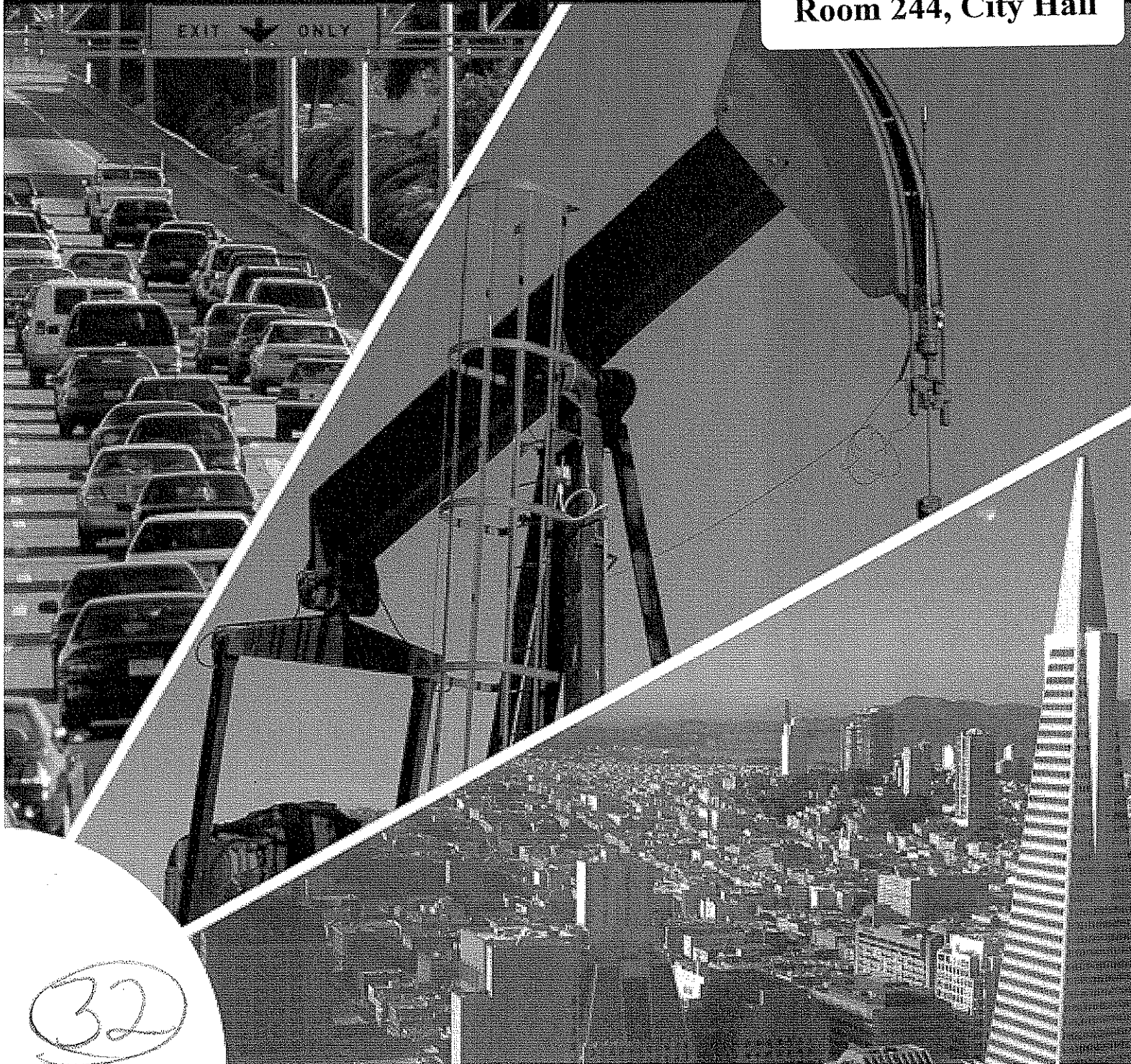
