9 8709 AS SHOWN ON THAT CERTAIN MAP ENTITLED "MAP OF MISSION BAY" RECORDED  
10 ON JULY 19, 1999 IN BOOK Z OF MAPS AT PAGES 97-119 IN THE OFFICE OF THE  
11 RECORDER OF THE CITY AND COUNTY OF SAN FRANCISCO" comprising 9 sheets,  
12 approved the January 10, 2001 by Department of Public Works Order No.172,743 together with  
13 the Public Improvement Agreement for Mission Bay South Block 8709 Phase 1 (Blocks 41, 42,  
14 43, and 45) dated January 10, 2001 between the City and County of San Francisco and Catellus  
15 Development Corporation are hereby approved and adopted as the Official Final Map of "Mission  
16 Bay" (for Phase 1 Assessor's Block 8709 Lot 1.)

18       FURTHER MOVED, That the San Francisco Board of Supervisors accepts on behalf of  
19 the public for emergency vehicle access purposes those strips of land delineated and designated  
20 on said Final Map of Mission Bay as: "EMERGENCY VEHICLE ACCESS EASEMENT  
21 (E.V.A.E.)" and accepts subject to improvements all other dedications offered on this Final Map.

22       FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own and  
23 incorporates by reference herein as though fully set forth the findings made by the City Planning  
24 Department, by its letter dated December 19, 2000, that the proposed development is consistent




3 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own and


