8 of San Francisco to allow committee meetings of the San Francisco Board of Supervisors to  
9 be held outside of City Hall; and

10 WHEREAS, The 1996 Charter Section 2.103 continued to allow meetings of the San  
11 Francisco Board of Supervisors committees to be held outside of City Hall; and

12 WHEREAS, The Board of Supervisors on January 22, 2001, adopted Rule 5.9 of its  
13 Rules of Order which created the City and School District Committee to hear measures  
14 concerning issues of mutual interest that affect the City and School District, its employees,  
15 its students, and the families of its students, including the issue of the public use of the  
16 School District facilities; and

17 WHEREAS, The Board of Education on June 22, 1999 adopted Rule 5.6, Policy No.  
18 P120, creating the City and School District Committee with the same purpose as cited  
19 above and stating the City and School District Committee shall be comprised of two  
20 members of the Board of Supervisors and two members of the Board of Education; and,

21 WHEREAS, At the October 27, 1999 meeting of the City and School District  
22 Committee, it was decided to hold quarterly meetings at the Irving G. Breyer Board Meeting  
23 Room, Board of Education, 555 Franklin Street, First floor, San Francisco at 3:00 p.m.;


