19 subdivision is consistent with the Mission Bay North Redevelopment Plan and Plan
20 Documents (as such term is defined therein); and be it

21 FURTHER MOVED, this map is subject to a public improvement agreement entitled
22 Public Improvement Agreement for Mission Bay North Blocks 8705 and 8708/N3 and N3A
23 dated March 1, 2001. Said agreement is on file with the Clerk of the Board of Supervisors in
24 File No. 010435 and is incorporated herein by reference; and be it
