WHEREAS, On August 26, 2008, the Environmental Review Officer of the San Francisco Planning Department issued a certificate of determination of exemption/exclusion from environmental review (the "determination") for the demolition of an existing building and construction of a new three-story-over-basement single-family residence with two off-street parking spaces on the ground floor, located at 2626 Filbert Street (the "Project"). WHEREAS, By letter to the Clerk of the Board of Supervisors dated November 21, 2008, Brooke Sampson and Lori Brooke, on behalf of the Cow Hollow Association, filed an appeal of the determination to the Board of Supervisors, which the Clerk of the Board of Supervisors received on or around November 21, 2008; and,

WHEREAS, On December 16, 2008, this Board held a duly noticed public hearing to consider the appeal of the determination. Following the conclusion of the public hearing, the Board rendered a decision on the use of the exemption/exclusion for the project based on the written record before the Board in File No. <u>081530</u> which is hereby declared to be a part of this motion as if set forth fully herein, as well as all of the testimony at the public hearing in support of and opposed to the appeal; and,
