WHEREAS, Pursuant to Charter, Section 2.116, and the Rules of Order for the Board of Supervisors, Section 6.1.1, if a vacancy in the Office of Board President occurs prior to the end of the term, the Board shall by majority vote, elect one of its members to fill the unexpired portion of the term; and

WHEREAS, At the time designated for the election of a Board President, the presiding officer shall entertain nominations from the Supervisors for the position of President and the Clerk of the Board shall call the roll of Supervisors until a nominee receives a majority vote and a President is elected; and

WHEREAS, The Board may elect a new President in advance of the vacancy, and if the Board chooses to do so, the elected Supervisor would assume the Office of President upon Supervisor Chiu's resignation as a Supervisor and would serve as President until the expiration of the term at 12:00 p.m. on January 8, 2015; now, therefore, be it
