WHEREAS, The Board of Supervisors' Government Audit and Oversight Committee (GAO) conducted a public hearing to hear and respond to the Report on October 24, 2013; and subsequently the Board of Supervisors subsequently adopted Resolution No. 394-13 on November 5, 2013, reflecting the Board's responses to the Report; and

WHEREAS, The Board of Supervisors responded in Resolution No. 394-13 that Recommendation No. 3, which states: "The Department should provide additional resources to bring the Avatar system to a level that fully supports the Department's performance objective program. The Mayor and the Board of Supervisors should ensure that sufficient resources are available to implement this recommendation," required further analysis, and the Department of Public Health would report to the Board on the hiring of necessary staff to support the Avatar system within six months of the publication of the Civil Grand Jury report, from June 27, 2013, to no later than December 27, 2013; and

WHEREAS, All information related to the original Board proceedings regarding the Report is on file with the Clerk of the Board of Supervisors in File No. 130610, which is hereby declared to be a part of this Motion as if set forth fully herein; now, therefore, be it

MOVED, That the Board of Supervisors reports to the Presiding Judge of the 2012-2013 City and County of San Francisco Civil Grand Jury that an additional public hearing was held on April 10, 2014, by GAO to receive an update from City departments on the status of Recommendation No. 3 from the Report; and, be it

FURTHER MOVED, That the Board of Supervisors reports that Recommendation No. 3 has been implemented, as reported by the Office of the Mayor and the Department of Public Health; and, be it

FURTHER MOVED, That the Board of Supervisors urges the Mayor to cause the continued implementation of the accepted recommendation through his/her department heads and through the development of the annual budget.
