Motion establishing the 2015 Board of Supervisors Regular Meeting Schedule by suspending Board Rule 4.2 and by cancelling the Board meetings of January 6th and 20th, February 17th, May 26th, June 30th, September 1st, October 13th, November 10th, and November 24th, and by further cancelling all Board and Committee meetings during the summer and winter breaks from July 29th through August 31st, and December 16, 2015, through January 4, 2016.

WHEREAS, The Board's Rules of Order, Section 4.2, states the Board shall hold a regular meeting in the Legislative Chamber in City Hall each Tuesday at 2:00 p.m., unless it is a holiday, in which case the meeting shall be cancelled, as in the case of January 20th, February 17th, May 26th, September 8th, and October 13th; and

WHEREAS, The Rules of Order Section 4.2.1 states that during holiday periods, the application of specific days of the week described in the rules shall be revised by the Clerk of the Board as necessary for the efficient conduct of the legislative process, such as with the January 6th, June 30th, and November 10th cancelled meetings, due to the New Year's Day, Fourth of July, and Veteran's Day Holidays; and

WHEREAS, The Rules of Order Section 4.2 also states the Board shall not meet during the week after Thanksgiving, nor between December 24th and December 31st; and

WHEREAS, Similar to other sitting legislative bodies in the United States, the Board has established recess periods during the summer and winter which Members of the Board may plan to be away without missing any Board or Committee meetings or other important public business, and without causing difficulties in achieving a quorum; and

WHEREAS, The Board is constrained by certain administrative and legislative deadlines and may decide to meet on August 4th to conduct the City's business; now, therefore, be it

MOVED. That the Board of Supervisors hereby suspends Board Rule 4.2 to allow meetings after the Labor Day holiday and during the week of Thanksgiving; and, be it

FURTHER MOVED, That there shall be no Committee meetings during the week of November 23, 2015, to enable staff to finalize the Board agenda and packet materials during the holiday week of Thanksgiving; and, be it
