Section 1551. The width of sidewalks on a portion of Front Street between Sacramento and California Streets, shall be as shown on Department of Public Works drawing labeled Q-20-514, and

SECTION 2: The City Planning Department in its letter dated October 11, 2000 stated that the above described change of official sidewalk width is in conformity with the General Plan, and made findings of consistency with the Eight Priority Policies of Planning Code Section 101.1.
