11 Section 1. The San Francisco Police Code is hereby amended by adding Section
12 1183.31, to read as follows:

13 Sec. 1183.31. Restricted areas. El Camino Del Mar, between the Presidio (approximately 290
14 feet east of Twenty-Fifth Avenue) and Twenty-Fifth Avenue, and Twenty-Fifth Avenue between Lake
15 Street and El Camino del Mar. This Section shall expire on December 31, 2002.




