4 **against the City and County of San Francisco and AT&T Corporation in exchange for a**  
5 **waiver of costs by San Francisco; the lawsuit was filed on February 19, 2002 in San**  
6 **Francisco Superior Court, Case No. 02-404691; entitled Nisbet and David v. AT&T Corp.**  
7 **and the City and County of San Francisco; other material terms of said settlement are**  
8 **that AT&T will pay costs and fees to plaintiffs' counsel, and will provide pre-paid**  
9 **telephone calling cards with a value of \$50,000 for free distribution in San Francisco;**  
10 **these cards will be distributed through the San Francisco Convention and Visitors**  
11 **Bureau, the San Francisco Department of Public Health, and the San Francisco**  
12 **Department of Human Services.**



14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The City Attorney is hereby authorized to settle the action entitled "Nisbet  
16 and David v. AT&T Corporation and the City and County of San Francisco, San Francisco  
17 Superior Court, Court No. 02-404691 by the payment of around \$75,000 in fees and costs by  
18 AT&T Corporation and the donation by AT&T of \$50,000 worth of prepaid calling cards for  
19 distribution in San Francisco; San Francisco will not contribute anything to the settlement but  
20 will waive its costs; the San Francisco Convention and Visitors Bureau, the San Francisco  
21 Department of Public Health, and the San Francisco Department of Human Services are  
22 hereby authorized to accept and to distribute, free of charge, the pre-paid calling cards that  
23 will be provided by AT&T as part of this settlement.

1 Section 2. The above-named action was filed in San Francisco Superior Court on  
2 February 19, 2002, and the following parties were named in the lawsuit: Scott Nisbet and  
3 Daniel David, plaintiffs, and AT&T Corporation, co-defendant.




