4 **Bank Stabilization; designating said facilities for public use and maintenance**  
5 **purposes; adopting findings that such actions are consistent with the City's General**  
6 **Plan, priority policy findings of City's Planning Code section 101.1, and the Mission**  
7 **Bay South Redevelopment Plan; accepting Department of Public Works Order No.**  
8 **174,026; and authorizing official acts in connection with this ordinance.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Findings.

14 (a) Title to the underlining property for the proposed Park P8 improvements is held as  
15 two parcels, one held as City fee and the other held as State Trust Property subject to Port  
16 jurisdiction. The use of the property consistent with public park improvements is permitted  
17 under the terms of the State Trust.

18 (b) The San Francisco Redevelopment Agency, in a letter dated March 20, 2003,  
19 determined that the acceptance of Park P8 Bank Stabilization facilities (the "Project") and  
20 other actions herein set forth are consistent with the Plan and Plan Documents. A copy of the  
21 Redevelopment Agency letter is on file with the Clerk of the Board of Supervisors in File No.  
22 030510 and is incorporated by reference as though fully set forth herein.

23 (c) The San Francisco Redevelopment Agency on March 20, 2003 signed and  
24 accepted the Catellus Conditional Assignment of Warranties and Guaranties. A copy of the

1 Assignment is on file with the Clerk of the Board of Supervisors in File No. 030510

2 and is incorporated by reference as though fully set forth herein.

3 (d) The City Planning Department, in a letter dated January 21, 2003 determined that  
4 the acceptance of Park P8 Bank Stabilization facilities and other actions herein set forth are  
5 within the scope of the General Plan consistency findings of Case No. 96.771R and the eight  
6 priority policies of Planning Code Section 101.1 and the contemplated actions do not trigger  
7 the need for subsequent environmental review pursuant the California Environmental Quality  
8 Act (CEQA) (California Public Resources Code Sections 2100 et seq.). A copy of the Planning  
9 Department letter is on file with the Clerk of the Board of Supervisors in File No.

10 030510 and is incorporated by reference as though fully set forth herein.

11 (e) The Port of San Francisco ("Port"), in a letter dated February 12, 2003 determined  
12 that the acceptance of Park P8 Bank Stabilization facilities is consistent with the "Park P8  
13 Bank Stabilization Plan" approved by or on behalf of the DPW Director, January 18, 2002",  
14 and any authorized revisions or contract change orders thereto, that said facilities have been  
15 constructed in accordance with all applicable City codes, regulations, standards and the Plan  
16 and Plan Documents governing this project. A copy of the Port letter is on file with the Clerk of  
17 the Board of Supervisors in File No. 030510 and is incorporated by reference as though  
18 fully set forth herein.

19 (f) In DPW Order No. 174,026, dated March 24, 2003, the Director of the Department  
20 of Public Works and the City Engineer certified that the Park P8 Bank Stabilization  
21 improvements have been inspected and were certified as complete on March 12, 2003, that  
22 the Project has been constructed in accordance with the Project Plans and Specifications and  
23 all City codes, regulations, standards and Mission Bay South Plan and Plan Documents  
24 governing this project, that such improvements are ready for their intended use and the  
25 Project is recommended for formal acceptance of acquisition facilities and acceptance for

1 maintenance purposes. A copy of the DPW Order is on file with the Clerk of the Board of  
2 Supervisors in File No. 030510 and is incorporated by reference as though fully set  
3 forth herein.

4 (g) All capitalized terms relating to Mission Bay shall have the terms ascribed to them  
5 pursuant to the Mission Bay South Plan and Plan Documents approved and adopted by the  
6 Board of Supervisors of the City and County of San Francisco by Ordinance No. 335-98, on  
7 November 2, 1998, a copy of which is in Clerk of the Board of Supervisors File No. 030510.

8 Section 2. Adoptions, Approvals.

9 (a) The Board of Supervisors adopts as its own the consistency findings of the San  
10 Francisco Redevelopment Agency in connection with the acceptance of Park P8 Bank  
11 Stabilization facilities and other actions set forth herein.

12 (b) The Board of Supervisors adopts as its own the consistency findings and CEQA  
13 findings of the Planning Department in regard to the Park P8 Bank Stabilization project.

14 (c) The Board of Supervisors has reviewed and approves the City Engineer's  
15 certification and Director of the Department of Public Works recommendation concerning the  
16 acceptance of the Catellus irrevocable offer of the Park P8 Bank Stabilization Improvements  
17 dated January 28, 2003.

18 Section 3. Acceptance of Offer of Improvements.

19 (a) Pursuant to San Francisco Administrative Code Sections 1.51 et seq., the  
20 Acquisition Agreement dated June 1, 2001, and supplemented on October 1, 2002, by and  
21 between the Redevelopment Agency of the City and County of San Francisco and Catellus  
22 Development Corporation with respect to Park P8 Bank Stabilization Acquisition Facilities,  
23 and the Department of Public Works Order No. 174,026, dated March 24, 2003, the Board of  
24 Supervisors hereby accepts the Catellus irrevocable offer of the Park P8 Bank Stabilization  
25

1 Improvements dated January 28, 2003 and designates such facilities to public use and  
2 maintenance purposes, subject to the conditions listed in subsection (b).

3 (b) The Park P8 Bank Stabilization Improvements accepted by the Board pursuant to  
4 Subsection (a) are subject to the following: (1) acceptance of Park P8 Bank Stabilization  
5 facilities only, and (2) Catellus Development Corporation's warranty obligations under the  
6 Park P8 Bank Stabilization Plan permit continue as set forth in said permit.

7 (c) The Board of Supervisors hereby acknowledges Catellus' Conditional Assignment  
8 of all guaranties and warranties related to the construction of the above improvements.

9 Section 4. All actions heretofore taken by the officers of the City with respect to such  
10 Ordinance are hereby approved, confirmed and ratified, and the Mayor, Clerk of the Board,  
11 Director of Property, and Director of Public Works are hereby authorized and directed to take  
12 any and all actions which they or the City Attorney may deem necessary or advisable in order  
13 to effectuate the purpose and intent of this Ordinance, including, but not limited to, the filing of  
14 the Ordinance in the Official Records of the City and County of San Francisco.
