9 Be it ordained by the People of the City and County of San Francisco:


10 Section 1. The San Francisco Administrative Code is hereby amended by adding  
11 Sections 2A.260, to read as follows:

12 Sec. 2A.260. DEPARTMENT OF CONVENTION FACILITIES.

13 (a) Department of Convention Facilities. There shall be a Department of Convention  
14 Facilities. The City Administrator, with the concurrence of the Mayor, shall appoint and may remove a  
15 Director who shall serve as department head and appointing officer for the Department. The  
16 Department shall include such officers and employees as are authorized pursuant to the budgetary and  
17 fiscal provisions of the Charter.

18 (b) Duties and Functions. The Department shall be responsible for the management and  
19 administration of City-owned or operated convention facilities, and such other duties and functions as  
20 assigned pursuant to the Charter or by ordinance.
