Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Traffic Code is hereby amended by amending Section 39 as follows:

SEC. 39. TAXICAB STANDS.

- (a) Taxicab stands designated as such pursuant to the provisions of Section 1117, Article 16, Chapter VIII, Part II, of the Municipal Section 1108, Article 16, of the <u>Police</u> Code shall be marked with such signs, wording or colors as may be designated by the Department of Parking and Traffic.
- It shall be unlawful for the operator of any vehicle other than a vehicle duly authorized by the Chief of Police to occupy space in any stand referred to in Subsection (a) of this Section at any time of the day or night.
