12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The San Francisco Administrative Code is hereby amended by adding  
14 Section 10.19-5, to read as follows:

15 **SEC. 10.19-5. QUARTERLY REPORT ON DEPARTMENTAL SPENDING.**

16 Not later than eight weeks after the end of each of the first three quarters of the fiscal year, all  
17 City departments shall submit a report to the Board of Supervisors identifying any areas, by  
18 appropriations item, where the department's rate of spending, if continued for the rest of the fiscal year,  
19 would exceed the total appropriation for the fiscal year for that item. The Budget Analyst shall  
20 review all reports submitted by a department pursuant to this section.
