10 Section 1. The San Francisco Campaign and Governmental Conduct Code is hereby
11 amended by adding Section 3.1-417, to read as follows:

12 **SEC. 3.1-417. SAN FRANCISCO COMMUNITY HEALTH JOINT POWERS**

13 **AUTHORITY.**

14 Disclosure Category 2. Persons in this category shall disclose all investments and business
15 positions in business entities, and income from any source, including nonprofit entities, which may
16 receive funds from the Community Health Joint Powers Authority, or contract with the Community
17 Health Joint Powers Authority, or provide services of the type utilized by the Community Health Joint
18 Powers Authority, including but not limited to health care providers and community-based health and
19 social service organizations.




