Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Health Code is hereby amended <u>by adding amending</u> Section 139 XXX, to read as follows:

SEC. 139. X WRITTEN INFORMED CONSENT AND PRE-TEST COUNSELING PRIOR TO HIV TESTING. Requiring written informed consent and pre-test counseling

## prior to HIV testing.

(a) The Board of Supervisors encourages the San Francisco Department of Pubic Health to modify the San Francisco General Hospital Medical Center's policies and procedures to require that providers obtain written informed consent from and provide pre-test counseling to patients shall be required at sites funded or operated by the Department of Public Health prior to an individual receiving, consistent with state and federal law, before administering an HIV antibody test to such patients.

(b) Written informed patient consent may consist of documentation by the provider in the patient's medical record if such consent satisfies state and federal law.
