Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.).

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.06, to read as follows:

SEC. 12.06. COIT TOWER.

(a) The following fees shall be charged for admission to Coit Tower:

Age Category	Admission Fe
Adult	\$3.75 <u>4.50</u>
Adult with Muni Pass	\$ <i>3.00</i>
Senior	\$ <del>2.50</del> <u>3.50</u>
Child (6-12 years)	\$ <i>1.50</i> <u>2.00</u>
Child (under 6 years)	\$0.00

(b) Audio tours: Upon development, and approval by the Commission, of an audio tour for Coit Tower, the entrance fee for the facility shall be increased by \$1.00 to cover the cost of rental of the tour. The rental fee for the audio tour without admission to the rest of the facility will be \$3.00.
