12 Section 1. The hereinafter designated section and item of Ordinance No. 203-06  
13 (Annual Salary Ordinance, FY 2006-2007) is hereby amended so that the same shall read as  
14 follows:

15 Section 2.5 COMPENSATION OF PLANNING COMMISSIONERS FOR ATTENDANCE AT  
16 PLANNING COMMISSION MEETINGS

17 Each commissioner serving on the Planning Commission may receive full compensation for his  
18 or her attendance at each meeting of the commission, as enumerated and included herein, provided  
19 that the commissioner is present at the beginning of the first action item on the agenda for such  
20 meeting for which a vote is taken until the end of the public hearing on the last calendared item. A  
21 commissioner of the Planning Commission who attends a portion of a meeting of the Planning  
22 Commission, but does not qualify for full compensation, may receive one-quarter of the compensation  
23 available for his or her attendance at each meeting of the commission, as enumerated and included  
24 herein.




