10 Section 1. After a duly noticed public hearing and due deliberation, as required by
11 Section 2006 of the California Streets and Highways Code, and due to the resignation of
12 Edwin M. Lee, previous Director of the Department of Public Works, this Board of Supervisors
13 hereby finds that it is in the interest of economy and efficiency to appoint the current Director
14 of the Department of Public Works to serve as Road Commissioner, and hereby further finds
15 that the said Director is qualified and competent to handle the road and highway work of the
16 City and County of San Francisco.

17 Section 2. The Board of Supervisors hereby appoints Fred V. Abadi, Ph.D., Director of
18 the Department of Public Works, to serve as Road Commissioner for the City and County of
19 San Francisco.

20 Section 3. Ordinance No. 18-02, a copy of which is on file with the Clerk of the Board
21 of Supervisors in File No. 070076, appointing Edwin M. Lee, previous Director of
22 Public Works, to serve as Road Commissioner for the City and County of San Francisco is
23 hereby repealed.
