Ordinance amending Ordinance No. 1061 entitled "Regulating the Width of Sidewalks" by adding thereto Section 1571 to change the official sidewalk widths on the westerly side of Stockton Street between Geary and Ellis Streets; making findings pursuant to the General Plan and Planning Code Section 101.1; and requiring relocation, modification, or both of facilities affected by the sidewalk width change.

Be it ordained by the People of the City and County of San Francisco: Section 1. The Board of Supervisors adopts as its own and incorporates by reference herein as though fully set forth the findings made by the Planning Department in its letter dated August 1, 2002, which stated that this project is in conformity with the San Francisco General Plan and the priority policies of Planning Code Section 101.1. A copy of said letter is in the Clerk of the Board of Supervisors File No. 070224 and is incorporated herein by reference.

Section 2. In accordance with the Department of Public Works' Order No. 176,696, a copy of which is in the Clerk of the Board of Supervisors File No. $OTO_{22}Y$, Board of Supervisors Ordinance No. 1061, entitled "Regulating the Width of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors Book of General Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a new section to read as follows:

Section 1571. The official sidewalk widths on the westerly side of Stockton Street shall be as shown on Department of Public Works drawings Q-20-616, FILE NO.

Section 3. The Department of Parking and Traffic, as is necessary as a result of this Ordinance, shall make arrangements with public utility companies and City Departments for the relocation, modification, or both of existing utility facilities in the affected sidewalk and street areas.
