Be it ordained by the People of the City and County of San Francisco:

Section 1. (a) Environmental Findings. The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seg.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 07025 and is incorporated herein by reference.

(b) Additional Findings. As a result of a computer generated error, the Department of Public Works selected an additional building consisting of three (3) units in the 2007 condominium conversion lottery. These 3 units would exceed the annual condominium conversion limit of 200 units as set forth in Section 1396 of the Subdivision Code. This legislation would waive the 200-unit limit in order to allow the conversion of this single 3-unit building. This legislation will serve the public interest as it will compensate for this error and will not negatively affect the selection of any building in the 2007 condominium lottery. including the assignment of buildings to the stand-by list.

Supervisor McGoldrick **BOARD OF SUPERVISORS** Section 2. This section is uncodified. Notwithstanding the annual 200-unit condominium conversion limit set forth in Subdivision Code Section 1396, this Ordinance shall authorize the conversion of one additional building consisting of three (3) units that was accidentally selected in the 2007 condominium conversion lottery. This legislation also shall delete three (3) units from the 2008 condominium conversion lottery so that no more than 197 units are selected for conversion that year. The three (3) units shall be removed from the Pool B portion of the condominium lottery as set forth in Section 1396.1.
