[Conflict of Interest Code Amendments.]

Ordinance amending Chapter 1 of Article III of the Campaign and Governmental Conduct Code by amending sections 3.102.5, 3.1-105, 3.1-120, 3.1-145, 3.1-150, 3.1-155, 3.1-160, 3.1-175, 3.1-195, 3.1-205, 3.1-207, 3.1-218, 3.1-230, 3.1-242, 3.1-245, 3.1-252, 3.1-265, 3.1-267, 3.1-270, 3.1-275, 3.1-285, 3.1-312, 3.1-315, 3.1-320, 3.1-325, 3.1-335, 3.1-340, 3.1-345, 3.1-350, 3.1-365, 3.1-375, 3.1-390, 3.1-395, 3.1-420, 3.1-435, 3.1-440, 3.1-445, and 3.1-500; renumbering sections 3.1-252, 3.1-265, and 3.1-375 as sections 3.1-255, 3.1-362 and 3.1-252, respectively; deleting sections 3.1-109, 3.1-168, 3.1-170, 3.1-220, 3.1-222, 3.1-290, 3.1-400, 3.1-423, and 3.1-430; and adding sections 3.1-108, 3.1-193, 3.1-251, 3.1-253, and 3.1-457, all to update the list of designated employees who must file financial disclosure statements, to modify the applicable disclosure categories, and to clarify that consultants for each City agency must file financial disclosures in disclosure category 1 unless the agency's director has indicated otherwise.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The San Francisco Campaign and Governmental Conduct Code is hereby amended by amending Sections 3.102.5, 3.1-105, 3.1-120, 3.1-145, 3.1-150, 3.1-155, 3.1-160, 3.1-175, 3.1-195, 3.1-205, 3.1-207, 3.1-218, 3.1-230, 3.1-242, 3.1-245, 3.1-252, 3.1-265, 3.1-267, 3.1-270, 3.1-275, 3.1-285, 3.1-312, 3.1-315, 3.1-320, 3.1-325, 3.1-335, 3.1-340, 3.1-345, 3.1-350, 3.1-365, 3.1-375, 3.1-390, 3.1-395, 3.1-420, 3.1-435, 3.1-440, 3.1-445, and 3.1-500, to read as follows:

SEC. 3.1-102.5. FAILURE TO FILE.

BOARD OF SUPERVISORS

1 (a) Subject to the removal and Civil Service provisions of the Charter as well as any
2 applicable Civil Service Rules, any officer or employee of the City and County of San
3 Francisco who fails to file any statement required by Sections 3.1-101 and 3.1-102 of the
4 Campaign and Governmental Conduct Code within 30 days after receiving notice from the
5 Ethics Commission of a failure to file may be subject to disciplinary action by his or her
6 appointing authority, including removal from office or termination of employment.

7 (b) The Ethics Commission may issue a letter to an appointing authority
8 recommending removal of any City officer or termination of any City employee who has failed
9 to file a statement required by Sections 3.1-101 and 3.1-102 of the Campaign and
10 Governmental Conduct Code if the City officer or employee has not filed the required
11 statement within 30 days of receiving notice from the Ethics Commission of his or her failure
12 to file.

13 ~~(c) Every appointing authority whose appointees file statements required by Sections 3.1-101~~
14 ~~and 3.1-102 of the Campaign and Governmental Conduct Code with the Ethics Commission shall~~
15 ~~provide written notice to the Ethics Commission of the name of any appointee who has assumed or left~~
16 ~~office or employment. Such notice shall be provided within 15 days of the City officer or employee~~
17 ~~assuming or leaving office or employment. Failure to provide such notice may constitute official~~

20 **SEC. 3.1-105. NOTICE OF APPOINTMENT AND RESIGNATION.**

21 (a) Every appointing authority whose appointees file statements required by Sections 3.1-101
22 and 3.1-102 of the Campaign and Governmental Conduct Code with the Ethics Commission shall
23 provide written notice to the Ethics Commission of the name of any appointee who has assumed or left
24 office or employment. Such notice shall be provided within 15 days of the City officer or employee
25

1 assuming or leaving office or employment. Failure to provide such notice may constitute official
2 misconduct.

3 (b) Whenever the Mayor or a board or commission appoints a department head, or
4 receives the resignation or retirement notice of a department head, the official or the secretary
5 to the board or commission who makes the appointment or receives the resignation or
6 retirement notice, ~~shall promptly inform the Ethics Commission. The official or secretary shall also~~
7 inform the department head of the necessity to file within 30 days ~~of~~ assuming office or
8 leaving office a statement of economic interests. Upon receiving notice of the appointment, or
9 the resignation or retirement, of the department head, the Ethics Commission shall perform
10 the required duties of the filing officer and obtain the required statement of economic interests.

12 **SEC. 3.1-120. AIRPORT COMMISSION.**

13 (a) **Disclosure Category 2.** Persons in this category shall disclose all investments
14 and business positions in business entities and income from any source which provides, or
15 contracts with the City and County of San Francisco and its Airport_s Commission to provide,
16 services, supplies, materials, machinery or equipment to the Airport_s Commission.

17 (b) **Disclosure Category 3.** Persons in this category shall disclose all investments
18 and business positions in business entities, interests in real property, and income from any
19 source subject to the regulatory, permit or licensing authority of the Airport_s Commission.




