13 Section 1. The San Francisco Traffic Code is hereby amended by amending Section  
14 175.29, to read as follows:

15 Sec. 175.29

16 A prima facie speed limit of 30 miles per hour is hereby established on ~~3rd~~Third Street  
17 between Evans Avenue and Kirkwood Street; and on Third Street between Shafter Street and  
18 Bayshore Boulevard Jamestown Avenue.




