3 **Ordinance amending Ordinance No. 1061 entitled “Regulating the Width of Sidewalks”**  
4 **by adding thereto Section 1574 to change the official sidewalk width on the northerly**  
5 **side of Jessie Street westerly of Ecker Street; making environmental findings and**  
6 **findings pursuant to the General Plan and Planning Code Section 101.1; and requiring**  
7 **relocation, modification, or both of facilities affected by the sidewalk width change.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The Board of Supervisors adopts as its own and incorporates by reference  
14 herein as though fully set forth the Planning Department findings in its letter dated December  
15 13, 2006. Said letter stated that the actions contemplated herein are consistent with the  
16 General Plan and in conformance with the Eighth Priority Policies of Planning Code Section  
17 101.1. A copy of said letter is on file with the Clerk of the Board of Supervisors in File No.  
18 070764.

19 Section 2. In the abovementioned letter, the Planning Department also determined that  
20 the actions contemplated in this Ordinance are in compliance with the California  
21 Environmental Quality Act (California Public Resources Code sections 21000 et seq.). Said  
22 determination is incorporated herein by reference.

23 Section 3. In accordance with the Department of Public Works’ Order No. 176,789, a  
24 copy of which is on file with the Clerk of the Board of Supervisors File No. 070764,  
25 Board of Supervisors Ordinance No. 1061, entitled “Regulating the Width of Sidewalks,” a


1 copy of which is in the Clerk of the Board of Supervisors Book of General Ordinances, in  
2 effect May 11, 1910, is hereby amended by adding thereto a new section to read as follows:

3 Section 1574. The official sidewalk width on the northerly side of Jessie Street westerly of Ecker  
4 Street shall be as shown on Department of Public Works drawing Q-20-641, a copy of which is on file  
5 with the Clerk of the Board of Supervisors in File No. 070764.

6 Section 4. Golden Gate University, as is necessary as a result of this Ordinance, shall  
7 make arrangements with public utility companies and City departments concerning relocation,  
8 modification, or any affected public facilities. Any required relocation, modification, or both of  
9 said facilities shall be at no cost to the City and County of San Francisco.


