13 Section 1. The City Attorney is hereby authorized to settle the action entitled "City and

14 County of San Francisco, et al., v. Michael Levine, et al."; San Francisco Superior Court,

15 Court No. 452-470 by the payment of \$30,000 and that Judgment is to be entered against

16 Michael Levine personally in the amount of \$30,000, that payment of \$15,000 is to be made at

17 the time of finalization of the settlement of this matter, that the remaining payment of \$15,000

18 is to be in monthly installments over a period of 18 months, and if any payment is late, the






