Section 2. Authorization to Accept and Expend Funds.

The United States Department of Agriculture provides funds to the City and County of San Francisco to operate the Summer Food Service Program. The funding will provide children ages 0 - 18 with free lunches during the summer months from June to August 2008. An average of 5,000 children will be served lunch each day during the summer at approximately 100 sites throughout the City. The United States Department of Agriculture has created a pilot Year-Round Feeding program to provide reimbursement funding for sponsors to provide after school snacks for children.
