Be it ordained by the People of the City and County of San Francisco: Section 1. Findings. The Board of Supervisors hereby finds and determines as follows: (a) Pursuant to Planning Code Section 302, The Board finds that this ordinance will serve the public necessity, convenience and welfare for the reasons set forth in Planning Commission Resolution No. 17675, and incorporates such reasons by this reference thereto. (b) The Board finds that this ordinance is in conformity with the Priority Policies of Section 101.1(b) of the Planning Code and the General Plan and hereby adopts the findings of the Planning Commission, as set forth in Planning Commission Resolution No. 17675 and incorporates said findings by this reference as if fully set forth herein.

(c) On January 6, 2008, the Planning Department issued a General Rule Exclusion determining that the proposal is exempt from further review under the California Environmental Quality Act ("CEQA) (California Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations Title 14 Sections 15000 et seq.), and Chapter 31 of the San Francisco Administrative Code ("Chapter 31").

Planning Department BOARD OF SUPERVISORS (d) On August 8, 2008, the Planning Commission held a duly noticed public hearing and in Resolution No. 17675, the Planning Commission recommended amendments to the Zoning Map of the City and County of San Francisco for Assessor's Block 6753, Lot 063. Said amendments and accompanying maps and property descriptions, copies of which are on file with the Clerk of the Board of Supervisors in File No. 081356, are incorporated by reference herein.

Section 2. Amendment of Section 11 of the Zoning Map.

The San Francisco Planning Code, Zoning Map Sheet 11, is hereby amended, so that the entire area of Assessor's Block 6753, Lot 063 will be rezoned from a zoning designation of P (Public) to a zoning designation of RH-2 (Residential, House Districts, Two-Family).
