Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

[Recreation and Park—Day Camp Fees.]

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et. seq.). Said determination is on file with the Clerk of the

Board of Supervisors in File No. \_\_\_\_\_\_ and is incorporated herein by reference.

Section 2. The San Francisco Park Code is hereby amended by amending Section 12.15, to read as follows:

## SEC. 12.15. DAY CAMP FEES.

The following fees shall be charged for Recreation and Park Department day camps per week. <u>Half-day camps are half of the amount shown</u>.
