

1 [Administrative, Business and Tax, Fire, Health, and Police Codes - Business License Fees]

2
3 **Ordinance amending various sections of the San Francisco Business and Tax**
4 **Regulations Code, Administrative Code, Fire Code, Health Code, and Police Code to:**
5 **1) establish March 31 as the date for the annual renewal of certain business licenses;**
6 **2) apply a schedule of penalties for failure to timely renew certain business licenses;**
7 **and 3) require Departments to post current business license fees on their websites.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The San Francisco Administrative Code is hereby amended by amending
14 Section 26.26, to read as follows:

15 **SEC. 26.26. FEE.**

16 The owner of the Deemed Approved Off-Sale Alcohol Use shall ~~each~~ be required to pay
17 an annual fee of \$264.00 to cover the cost of administering the Deemed Approved Off-Sale
18 Alcohol Use Education and Outreach Program and the cost of the City Attorney. This annual
19 fee shall be billed by and paid to the Office of the Treasurer &and Tax Collector, which shall
20 deposit the monies collected in the Deemed Approved Off-Sale Alcohol Continuing Project
21 Account, as set forth in Section 26.27. In the event that the owner of the Deemed Approved
22 Off-Sale Alcohol Use fails to pay the fee during a given fiscal year, the Office of the Treasurer
23 &and Tax Collector shall notify the Department of Public Health, which may request that the
24 City Attorney pursue collection of the penalties.

25 Beginning with fiscal year 2006-2007, the annual fee may be adjusted each year,
without further action by the Board of Supervisors, to reflect changes in the relevant

BOARD OF SUPERVISORS

1 Consumer Price Index, as determined by the Controller. No later than April 15th of each year,
2 the Department of Public Health shall submit the annual fee to the Controller, who shall apply
3 the price index adjustment to produce a new annual fee for the following year. No later than
4 May 15th of each year, the Controller shall file a report with the Board of Supervisors reporting
5 the new annual fee and certifying that: (a) the annual fee produces sufficient revenue to
6 support the proposed costs of providing the services in the upcoming fiscal year for which the
7 annual fee is being charged and (b) the annual fee will not produce revenue that exceeds the
8 proposed costs of providing the services in the upcoming fiscal year for which the annual fee
9 is charged. Notwithstanding the procedures set forth in this Section, the Board of Supervisors,
10 in its discretion, may modify the annual fee by ordinance at any time. The license fee shall be
11 paid annually on or before March 31, in accordance with the provisions of Section 76.1 of the Business
12 and Tax Regulations Code.

13 A new Deemed Approved Off-Sale Alcohol Use or a Deemed Approved Off-Sale
14 Alcohol Use that undergoes a change in ownership after the enactment of the Deemed
15 Approved Off-Sale Alcohol Use Ordinance shall pay its first annual fee on a pro-rated basis
16 reflecting within 60 days of commencing operation or of the change in ownership. This first
17 annual fee payment shall be pro-rated based of the number of days left in the fiscal year. The
18 license fee shall be paid annually on or before March 31, in accordance with the provisions of Section
19 76.1 of the Business and Tax Regulations Code.

20 Upon the request of the owner of a Deemed Approved Off-Sale Alcohol Use, the
21 Department of Public Health may waive payment of the annual fee provided that the owner
22 can show to the satisfaction of the Department of Public Health all of the following:

23 (1) That the Deemed Approved Off-Sale Alcohol Use has been under the
24 same ownership for not less than the previous three years;

1 (2) That the annual fee for the Deemed Approved Off-Sale Alcohol Use has
2 been paid in a timely manner for not less than the previous three years; and

3 (3) That the Deemed Approved Off-Sale Alcohol Use has not been the
4 subject of a City Department-referred complaint or any administrative penalties or conditions
5 imposed by a Hearing Officer, the Board of Appeals, or the Board of Supervisors under the
6 provisions of this Chapter.

7 If the owner of the Deemed Approved Off-Sale Alcohol Use can show all of the above,
8 the Department of Public Health shall waive the fee indefinitely, provided, however, that if the
9 Deemed Approved Off-Sale Alcohol Use changes ownership or becomes the subject of a City
10 Department-referred complaint or any administrative penalties or conditions imposed by a
11 Hearing Officer, the Board of Appeals, or the Board of Supervisors under the provisions of this
12 Chapter the annual fee shall be immediately reimposed.

13
14 Section 2. The San Francisco Business and Tax Regulations Code is hereby amended
15 by adding Sections 76.1 and 76.2, deleting Sections 76 and 80, and amending Sections 78,
16 93, 93.1, 120, 122, 224, 225, 226, 227, 228, 229, 230, 231, 232, 233, 234, 235, 236, 237, 238,
17 239, 240, 241, 242, 243, 244, 245, 246, 247, 248, 249.1, 249.5, 249.6, 249.7, 249.12, 249.13,
18 249.15, and 249.16, to read as follows:

19 ~~SEC. 76. LICENSES PAYABLE IN ADVANCE, WHERE PAYABLE, PENALTY FOR NONPAYMENT.~~

20 ~~Unless otherwise specifically provided, in all cases of annual licenses, collectible on the first~~
21 ~~day of January, April, July or October, fees for new licenses issued prior to or subsequent to said date~~
22 ~~shall be prorated to the end of the yearly period on a monthly basis.~~

23 ~~In all cases of licenses on new business collectible at periods other than the months of October,~~
24 ~~January, April and July, the Tax Collector shall prorate on a monthly basis the amount or license fee~~
25 ~~for any given quarter.~~

1 ~~Whenever a license tax is imposed by Ordinance it shall be unlawful to do or perform the act or~~
2 ~~to carry on the business, trade, profession or calling for which a license is required or to own, keep or~~
3 ~~use the article or thing, for the owning, keeping or using of which a license is required, unless such~~
4 ~~license be first procured.~~

5 ~~All licenses are payable, when due, at the office of the Tax Collector, in the City Hall, and if not~~
6 ~~paid within 30 days after the same become due, the Tax Collector shall add 10 percent to the amount of~~
7 ~~the license as a penalty for nonpayment. If the license is not paid within 60 days after the same~~
8 ~~becomes due, the Tax Collector shall add 15 percent to the amount of the license as a penalty for~~
9 ~~nonpayment. If the license is not paid within 90 days after same becomes due, the Tax Collector shall~~
10 ~~add 25 percent to the amount of the license, as a penalty for nonpayment, provided, however, when a~~
11 ~~licensee has failed for a period of six months or more to pay a license fee, and has allowed the license~~
12 ~~to become delinquent for this or a longer period, the Tax Collector shall, in such instance, impose a~~
13 ~~penalty of 25 percent on the total amount of license delinquent, and shall turn over a complete list of~~
14 ~~such licensees to the Chief of Police for arrest and prosecution, under the provisions of this Article.~~
15 ~~Nothing shall permit the exemption of the penalty mentioned in this Section.~~

17 **SEC. 76.1. LICENSES PAYABLE ON MARCH 31, WHERE PAYABLE, PENALTY FOR**
18 **NONPAYMENT, ANNUAL ADJUSTMENT.**

19 ~~(a) Commencing March 31, 2012, the following provisions shall apply to licenses that are~~
20 ~~renewable annually and are due and payable in full to the Treasurer and Tax Collector on March 31 of~~
21 ~~each year. The Tax Collector shall prorate fees for new licenses issued prior to March 31, or after~~
22 ~~March 31 to the end of the license period, on a monthly basis. The Tax Collector may not accept partial~~
23 ~~payments and may not refund fees paid by a licensee, if the licensee ceases operating the business prior~~
24 ~~to the end of the license period.~~

1 **(b)** Whenever a City ordinance imposes a license fee, it shall be unlawful to do or perform
2 the act or to carry on the business, trade, profession or calling for which City law requires the license
3 without obtaining and maintaining the required license.

4 All license fees are payable, when due, at the Office of the Treasurer and Tax Collector,
5 in City Hall, and if not paid within 30 days after they become due, the license shall expire by operation
6 of law and the licensee must obtain a new license and pay all applicable penalties specified below and
7 fees incurred under the previously expired license, provided, however, that the licensee shall not be
8 subject to the penalties unless the Tax Collector sent notice to the licensee prior to February 28, of the
9 same year, informing the licensee that the permit is about to expire. The notice that the license is about
10 to expire may be a part of the annual billing statement.

11 If a licensee does not pay the fee within 30 days after it becomes due, but the licensee
12 continues to operate the business, the Tax Collector shall add 10 percent to the amount of the license
13 fee as a penalty for nonpayment. If the licensee does not pay the fee within 60 days after it becomes
14 due, but the licensee continues to operate the business, the Tax Collector shall add 15 percent to the
15 amount of the license fee as a penalty for nonpayment. If the licensee does not pay the fee within
16 90 days after it becomes due, but the licensee continues to operate the business, the Tax Collector shall
17 add 25 percent to the amount of the license fee, as a penalty for nonpayment. If the licensee has failed
18 for a period of six months or more to pay a license fee, but has continued to operate the business, the
19 Tax Collector shall impose an additional penalty of 25 percent on the amount of the delinquent license
20 fee, and shall refer the delinquent licensee to the department charged with administering the permit for
21 administrative action on the permit. These penalties are mandatory and City officers and employees
22 may not waive them in whole or in part.

23 **(c)** Each department shall maintain on its website an up-to-date schedule of all fees that it
24 collects. The Municipal Code shall include an editor's statement informing the public that the fees
25 administered pursuant to this Section are subject to annual review and adjustment to reflect the City's

1 cost increases or decreases, which may include adjustments based upon the Consumer Price Index that
2 most accurately tracks increases and decreases in the City's cost for the function, service, or
3 undertaking that the fee will pay for, and that each department maintains on its website an up-to-date
4 list of the fees charged subject to adjustment. This subsection is not intended to change the processes
5 for adjustment of fees as provided in the Municipal Code.

6
7 **SEC. 76.2. LICENSES PAYABLE IN ADVANCE ON DATES OTHER THAN MARCH 31,**
8 **WHERE PAYABLE, PENALTY FOR NONPAYMENT, ANNUAL ADJUSTMENT.**

9 (a) Unless otherwise specifically provided, in all cases of annual licenses, collectible on the
10 first day of January, April, July or October, fees for new licenses issued prior to or subsequent to said
11 date shall be prorated to the end of the yearly period on a monthly basis.

12 In all cases of licenses on new business collectible at periods other than the months of October,
13 January, April and July, or on March 31 pursuant to Section 76.1, the Tax Collector shall prorate on a
14 monthly basis the amount or license fee for any given quarter.

15 (b) Whenever a license fee is imposed by ordinance it shall be unlawful to do or perform the
16 act or to carry on the business, trade, profession or calling for which a license is required or to own,
17 keep or use the article or thing, for the owning, keeping or using of which a license is required, unless
18 such license be first procured.

19 All licenses are payable, when due, at the Office of the Treasurer and Tax Collector, in City
20 Hall, and if not paid within 30 days after the same become due, the license shall expire by operation of
21 law and the licensee must obtain a new license and pay all applicable penalties specified below and
22 fees incurred under the previously expired license, provided, however, that the licensee shall not be
23 subject to the penalties unless the Tax Collector sent notice to the licensee prior to February 28, of the
24 same year, informing the licensee that the permit is about to expire. The notice that the license is about

5 license as a penalty for nonpayment. If the licensee does not pay the fee within 90 days after it becomes
6 due, but the licensee continues to operate the business, the Tax Collector shall add 25 percent to the
7 amount of the license, as a penalty for nonpayment. If the licensee has failed for a period of six months
8 or more to pay a license fee, but has continued to operate the business, the Tax Collector shall, impose
9 an additional penalty of 25 percent on the amount of the delinquent license fee, and shall refer the
10 delinquent licensee to the department charged with administering the permit for administrative action
11 on the permit. These penalties are mandatory and City officers and employees may not waive them in
12 whole or in part.

13 Each department shall maintain on its website an up-to-date schedule of all fees that it collects.
14 The Municipal Code shall include an editor's statement informing the public that the fees administered
15 pursuant to this Section are subject to annual review and adjustment to reflect the City's cost increases
16 or decreases, which may include adjustments based upon the Consumer Price Index that most
17 accurately tracks increases and decreases in the City's cost for the function, service, or undertaking
18 that the fee will pay for, and that each department maintains on its website an up-to-date list of the fees
19 charged subject to adjustment.

20
21 **SEC. 78. EVIDENCE OF LIABILITY.**

22 In any action brought under or arising out of any of the provisions of any Ordinance
23 imposing a license ~~tax~~ fee, the fact that a party thereto represented himself or herself as
24 engaged in any business or calling for the transaction of which a license is required, or that
25

1 such party exhibited a sign indicating such business or calling, shall be conclusive evidence of
2 the liability of such party to pay for a license.

3
4 **~~SEC. 80. APPLICANT TO BE EXAMINED.~~**

5 ~~In all cases where the rate of license tax is graduated according to the amount of business done,~~
6 ~~or according to any other matter peculiarly within the knowledge of the person liable for license, such~~
7 ~~person must be examined at the Tax Collector's office or upon the premises in regard to such matters,~~
8 ~~and must be required to subscribe to a sworn statement, or affidavit that he has, to the best of his~~
9 ~~knowledge and belief, truly answered all questions touching the amount of license or kind of license for~~
10 ~~which he applies or is liable.~~

11 ~~It is within the discretion of the Tax Collector to refuse to accept anything but an advanced rate~~
12 ~~of license tax until he has determined, by an inspection of account books or other evidence, that a lower~~
13 ~~rate is justifiable.~~

14 ~~In all cases where the rate of license tax is graduated according to the amount of business done~~
15 ~~periodically, as monthly, quarter or annually, the amount of license tax to be charged in advance shall~~
16 ~~be determined by the business done in the next month, quarter or year prior to the period for which the~~
17 ~~license tax is due, unless by Ordinance it be specifically provided otherwise. In case there have been no~~
18 ~~receipts for the previous month, quarter or year, the lowest rate of license tax shall be paid. This same~~
19 ~~rule for determining the amount of license tax shall apply wherever the amount of license tax is to be~~
20 ~~determined in accordance with the amount of profits made or the amount of commissions received, or~~
21 ~~the amount of sale made or the amount of receipts, or by any other contingency or circumstance.~~

1 **SEC. 93. MOTOR FUEL DISPENSING FACILITIES.**

2 Every person, firm or corporation engaged in the business of maintaining, conducting
3 or operating a motor fuel dispensing facility that requires a permit from the Fire Department
4 shall pay an annual license fee of \$344.00.

5 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
6 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

7
8 **SEC. 93. 1. SELF-SERVICE MOTOR FUEL DISPENSING FACILITIES.**

9 Every person, firm or corporation engaged in the business of maintaining, conducting
10 or operating a self-service motor fuel dispensing facility that requires a permit from the Fire
11 Department, and jointly administered by the Fire and Health Departments, shall pay an annual
12 license fee of \$344.00.

13 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
14 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

15
16 **SEC. 120. LAUNDRIES AND CLEANING AND DYEING WORKS.**

17 ~~(a) — Every owner, manager or lessee of a hand laundry will pay the following license fee~~
18 ~~annually: \$87.~~

19 ~~(b)(a)~~ Every owner, manager or lessee of a wash laundry will pay the following license
20 fee annually ~~in advance to the Tax Collector:~~ \$187.

21 ~~(c) — Every owner, manager or lessee of a cleaning, dyeing or cleaning and dyeing works will~~
22 ~~pay the following fee annually: \$22.~~

23 **(b)** Every person, firm or corporation engaged in the business of dry cleaning that
24 requires a permit from the Fire Department shall also pay an annual license fee of \$344.00 per
25 year.

1 ~~(d)~~(c) Every owner, manager or lessee of an automatic laundry (mechanical, pay-to-
2 operate, washing or dyeing machine) will pay the following license fee annually ~~in advance to~~
3 ~~the Tax Collector~~: \$29 plus \$11 per machine.

4 ~~(e)~~(d) Every owner, manager or lessee of a laundry delivery service will pay the
5 following license fee annually ~~in advance to the Tax Collector~~: \$21 per delivery vehicle per year.

6 ~~The license fees prescribed by this Section are due and payable the first day of January of each~~
7 ~~year. Fees for new licenses issued prior to January 1st shall be prorated to the end of such calendar~~
8 ~~year on a monthly basis.~~

9 The license fees set forth above shall be paid annually on or before March 31, in accordance
10 with the provisions of Section 76.1 of the Business and Tax Regulations Code.

11

12 **SEC. 122. LIVERY STABLES.**

13 All keepers or owners of stables or barns who rent or let horses, vehicles, or stalls, or
14 who board horses, shall pay a license fee of \$131 per year.

15 The license fee prescribed in this Section ~~is due and payable on an annual basis,~~
16 ~~commencing October 1, 1978~~shall be paid annually on or before March 31, in accordance with the
17 provisions of Section 76.1 of the Business and Tax Regulations Code.

18

19 **SEC. 224. STORAGE AND USE OF BATTERY SYSTEMS.**

20 Every person, firm or corporation storing or using a battery system that requires a
21 permit from the Fire Department shall pay an annual license fee of \$344.00.

22 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
23 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

1 **SEC. 225. WASTE HANDLING.**

2 Every person, firm or corporation engaged in the business of waste handling, including
3 but not limited to junk yards and wrecking yards, that requires a permit from the Fire
4 Department shall pay an annual license fee of \$344.00.

5 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
6 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

7
8 **SEC. 226. MAINTENANCE OF FIRE FIGHTER AIR SYSTEMS.**

9 Every person, firm or corporation engaged in business that involves the maintenance
10 or repair of a fire fighter air replenishment system that requires a permit from the Fire
11 Department shall pay an annual license fee of \$344.00.

12 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
13 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

14
15 **SEC. 227. COMBUSTIBLE DUST PRODUCING OPERATIONS.**

16 Every person, firm or corporation engaged in business that involves combustible dust
17 producing operations that require a permit from the Fire Department shall pay an annual
18 license fee of \$344.00.

19 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
20 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

21
22 **SEC. 228. FRUIT AND CROP RIPENING.**

23 Every person, firm or corporation engaged in business involving fruit and crop ripening
24 that requires a permit from the Fire Department shall pay an annual license fee of \$344.00.

1 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
2 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

3
4 **SEC. 229. HOT WORK OPERATIONS.**

5 Every person, firm or corporation engaged in business involving hot work operations
6 that require a permit from the Fire Department shall pay an annual license fee of \$344.00.

7 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
8 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

9
10 **SEC. 230. USE OF LIQUID OR GAS FUELED VEHICLES OR EQUIPMENT IN ASSEMBLY**
11 **BUILDINGS.**

12 Every person, firm or corporation engaged in business involving the use of liquid or gas
13 fueled vehicles or equipment in an assembly building that requires a permit from the Fire
14 Department shall pay an annual license fee of \$344.00.

15 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
16 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

17
18 **SEC. 231. USE OF REFRIGERATION EQUIPMENT.**

19 Every person, firm or corporation engaged in business involving the use of refrigeration
20 equipment that requires a permit from the Fire Department shall pay an annual license fee of
21 \$344.00.

22 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
23 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

1 **SEC. 232. AMUSEMENT BUILDINGS.**

2 Every person, firm or corporation engaged in business involving amusement buildings
3 that requires a permit from the Fire Department shall pay an annual license fee of \$344.00.

4 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
5 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

6
7 **SEC. 233. COVERED MALL BUILDINGS.**

8 Every person, firm or corporation engaged in business involving covered mall buildings
9 that requires a permit from the Fire Department shall pay an annual license fee of \$344.00.

10 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
11 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

12
13 **SEC. 234. PYROXYLIN PLASTICS.**

14 Every person, firm or corporation engaged in business involving the use of pyroxylin
15 plastics that requires a permit from the Fire Department shall pay an annual license fee of
16 \$344.00.

17 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
18 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

19
20 **SEC. 235. ROOFTOP HELIPORTS.**

21 Every person, firm or corporation engaged in business using a rooftop heliport that
22 requires a permit from the Fire Department shall pay an annual license fee of \$344.00.

23 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
24 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

1 **SEC. 236. TIRE REBUILDING PLANTS.**

2 Every person, firm or corporation engaged in business of maintenance and operating a
3 tire rebuilding plant that requires a permit from the Fire Department shall pay an annual
4 license fee of \$344.00.

5 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
6 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

7
8 **SEC. 237. PLACES OF PUBLIC ASSEMBLY AND OPEN-AIR ASSEMBLY.**

9 Every person, firm or corporation engaged in the business of maintaining, operating or
10 using a building, stadium or structure as a place of public assembly or an open-air assembly
11 that requires a permit from the Fire Department, and where a license is not required
12 elsewhere in the Municipal Code, shall pay an annual license fee of \$564.00 per year.

13 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
14 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

15
16 **SEC. 238. NITROCELLULOSE FILM AND PLASTICS.**

17 Every person, firm or corporation engaged in the business of processing, storing or
18 using nitrocellulose motion picture film or nitrocellulose plastics that requires a permit from the
19 Fire Department shall pay an annual license fee of \$344.00.

20 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
21 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

1 **SEC. 239. STORAGE OF CERTAIN COMBUSTIBLE MATERIALS.**

2 Every person, firm or corporation engaged in any business of storing combustible
3 fibers, waste materials, lumber or readily combustible materials, including high-piled storage,
4 that requires a permit from the Fire Department shall pay an annual license fee of \$344.~~00~~.

5 The license fee for the Fire Department permit shall be paid annually on or before March 31, in
6 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

7
8 **SEC. 240. STORAGE AND USE OF FLAMMABLE OR COMBUSTIBLE LIQUIDS.**

9 Every person, firm or corporation engaged in the business of storing, using or

9 agencies. The Chief of Police may by rule or regulation amend the Attorney General's list to
10 include additional items which the Chief has determined to be frequently stolen in the City and
11 County. Such additional items shall thereafter be considered tangible personal property for
12 purposes of this Article.

13
14 **SEC. 1279.2. ANTIQUE SHOPS; DEFINITION; PERMIT.**

15 (a) **Definition.** As used in this Article:

16 "Antique Shop" means a shop where secondhand merchandise is sold at retail but
17 where at least 90 percent, measured according to value, of the used or secondhand
18 merchandise on hand at any one time consists of objects of art, bric-a-brac, curios or
19 household furniture or furnishings, offered for sale upon the basis, express or implied, that the
20 value of the property, in whole or in substantial part, is derived from its age or from its
21 historical association.

22 (b) **Permit Required.** The operator of any antique shop may, in lieu of the secondhand
23 dealer's permit required by Section 1279.1 hereof, apply for and obtain a special permit from
24 the Chief of Police to conduct an antique shop. The license fee for an antique shop permit shall be
25

1 paid annually on or before March 31, in accordance with the provisions of Section 76.1 of the Business
2 and Tax Regulations Code.

3 (c) **Compliance with Provisions of Code.** The holder of an antique shop permit shall
4 comply with all the provisions of this Article pertaining to secondhand dealers.

5
6 **SEC. 1279.3. TRADE-IN DEALERS; DEFINITION; PERMIT.**

7 (a) **Definition:** As used in this Article:

8 "Trade-In Dealer" means a person who shall as his direct business activity engage in
9 the sale of new items of goods, wares, merchandise or articles of any description and who
10 during the course of the sale of said new items shall take in trade a used item but does not in
11 said business activity engage in the purchase of used items of goods, wares, merchandise or
12 articles of any description. Said "Trade-In Dealer" shall be of the following kind:

- 13 (1) Furniture and household goods;
14 (2) Radio and television and other electronic equipment;
15 (3) General.

16 (b) **Permit Required.** A "Trade-In Dealer" may, in lieu of the secondhand dealer's
17 permit required by Section 1279.1 hereof, apply for and obtain a special permit from the Chief
18 of Police to conduct a trade-in dealership in conjunction with his new sale operation. The
19 license fee for a "Trade-In Dealer" permit shall be paid annually on or before March 31, in
20 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

21 (c) **Compliance with Provisions of Code.** The holder of a trade-in permit shall
22 comply with all the provisions of this Article pertaining to secondhand dealers.

1 **SEC. 1295. GUIDES.**

2 (a) No person shall for hire, guide or escort people through or about the City and
3 County of San Francisco or any part thereof, unless he shall have paid a license fee in
4 advance; provided, however, that no license shall be issued hereunder unless the applicant
5 therefore shall first have obtained a written permit from the Chief of Police authorizing him to
6 act as such guide. The license fee shall be paid annually on or before March 31, in accordance with
7 the provisions of Section 76.1 of the Business and Tax Regulations Code.

8 (b) Every person desiring a permit pursuant to this Section shall file an application
9 with the Chief of Police upon a form provided by said Chief of Police and shall pay a filing fee.

10 (c) Every licensed guide, while soliciting employment or acting as guide, shall wear
11 conspicuously exposed on the outside lapel of his coat a badge, showing thereof his number
12 and the words LICENSED GUIDE. The design, size and arrangement of numbering and
13 lettering thereof shall be fixed by the Tax Collector, but shall be uniform. The badges shall be
14 furnished by the Tax Collector at a cost fixed by the Tax Collector to cover the cost of issuing
15 such badge, and shall be issued at the date of the issuance of the license herein provided for.
16 Only one badge shall be issued to each licensed guide.

17 (d) The provisions of this Section shall not apply to nonprofit organizations guiding
18 or escorting people through or about the City and County of San Francisco as part of an
19 educational program, or to individuals guiding or escorting people through or about the City
20 and County of San Francisco as part of an educational program sponsored by a nonprofit
21 organization. Upon request of the Police Department, a nonprofit organization claiming
22 exemption under this subsection shall provide verification in a form acceptable to the Chief of
23 Police of (1) its nonprofit organization status, and (2) the educational program of which the
24 tour is a component.

1 **SEC. 1309. LICENSE FEES.**

2 Every holder of a fortuneteller's permit shall pay at the ~~o~~Office of the Treasurer and Tax
3 Collector an annual license fee, payable in advance. The license fee shall be paid annually on or
4 before March 31, in accordance with the provisions of Section 76.1 of the Business and Tax
5 Regulations Code. The permit is not valid unless the license fee has been paid.

6
7 **SEC. 2626. LICENSE FEES.**

8 Every permittee who conducts, permits or assists in conducting or permitting any public
9 bath house as defined herein shall pay to the Tax Collector an annual license fee, payable in
10 advance. The license fee shall be paid annually on or before March 31, in accordance with the
11 provisions of Section 76.1 of the Business and Tax Regulations Code. In calculating the fees earned
12 herein, a percentage of the license fee as set by the Controller pursuant to Section 2.21 of this
13 Code shall be credited to the Department of Public Health pursuant to the provisions of
14 Section 6.402 of the Charter of the City and County of San Francisco. The license fee
15 prescribed in this Section is due and payable on a calendar year basis starting 30 days after the first
16 day of January, 1973, and in any subsequent calendar year shall be prorated with regard to the
17 calendar year on a monthly basis.

18
19 **SEC. 2818. LICENSE FEES.**

20 Every person who has received a permit to operate the business of pawnbroking shall,
21 ~~on the first day of January each year,~~ pay to the Tax Collector an annual license fee ~~payable in~~
22 ~~advance.~~ The license fee shall be paid annually on or before March 31, in accordance with the
23 provisions of Section 76.1 of the Business and Tax Regulations Code.

1 ~~The license fee prescribed in this Section is due and payable on a calendar year basis starting~~
2 ~~90 days after the effective date of this Article, prorated with regard to the calendar year on a monthly~~
3 ~~basis.~~

4 ~~Fees for new licenses issued after the first day of August, 1973, or in any subsequent calendar~~
5 ~~year shall be prorated on a monthly basis.~~

6 ~~No permit or license shall be initially issued pursuant to this Article after October 19, 1972,~~
7 ~~unless the revenue fee, as provided in Section 2.29 of this Code, shall have been paid to the Tax~~
8 ~~Collector.~~

9
10 **SEC. 3008. PERMIT EXPIRATION.**

11 The permit shall expire one year from the date of issuance and shall be renewable
12 thereafter upon an annual basis upon the filing with the Tax Collector of a statement by the
13 permittee providing his or her current address and current employer and upon payment of the
14 annual license fee. ~~Beginning January 1, 1982, permits shall be renewable upon payment of the~~
15 ~~annual license fee on a calendar year basis, that is, upon the first day of January of each calendar~~
16 ~~year. The transition from renewal on an annual basis to renewal on a calendar year basis shall be~~
17 ~~accompanied as follows. When the renewal date for a permit arises in 1982, the permittee shall pay a~~
18 ~~license fee prorated to the length of time remaining in calendar year 1982 on a monthly basis. All~~
19 ~~permits shall then be renewable, on a calendar year basis, as of January 1, 1983. The license fee shall~~
20 ~~be paid annually on or before March 31, in accordance with the provisions of Section 76.1 of the~~
21 ~~Business and Tax Regulations Code.~~

22
23 **SEC. 3062. PERMIT EXPIRATION.**

24 The permit shall expire one year from the date of issuance, and shall be renewable
25 thereafter upon an annual basis, and upon payment of the annual license fee. The license fee

1 shall be paid annually on or before March 31, in accordance with the provisions of Section 76.1 of the
2 Business and Tax Regulations Code.

3
4 **SEC. 3216A. ANNUAL LICENSE.**

5 Each organization proposing to conduct poker games pursuant to this Article shall
6 obtain an annual license. The license fee shall be paid annually on or before March 31, in
7 accordance with the provisions of Section 76.1 of the Business and Tax Regulations Code.

8 The fee for an annual license shall be in the amount set forth in Section 2.27 of the Police Code,
9 payable in advance to the Tax Collector.

10 The license fee prescribed in this Section is due and payable on a calendar year basis, starting
11 January 1st. Fees for a new license issued prior to January 1st, or after the first day of January, or in
12 any subsequent calendar year, shall be prorated with regard to the calendar year on a monthly basis.

13 Nonprofit charitable organizations that are duly certified to be senior citizen
14 organizations by the Commission on the Aging of the City and County of San Francisco shall
15 not be required to pay those fees established by Sections 3203A, 3208A and 3216A of this
16 Article.

17
18 **SEC. 3217. LICENSE FEES.**

19 Every organization granted a bingo game permit by the Chief of Police shall obtain
20 either a special license or an annual license by paying the required license fee to the Tax
21 Collector. The license fee shall be paid annually on or before March 31, in accordance with the
22 provisions of Section 76.1 of the Business and Tax Regulations Code.

1 **SEC. 3219. ANNUAL LICENSE.**

2 Each organization proposing to conduct more than 10 bingo games a year shall obtain
3 an annual license. The license fee shall be paid annually on or before March 31, in accordance with
4 the provisions of Section 76.1 of the Business and Tax Regulations Code.

5 ~~The fee for an annual license shall be payable in advance. The license fee prescribed in this~~
6 ~~Section is due and payable on a calendar year basis, starting January 1st. Fees for a new license issued~~
7 ~~prior to January 1st, or after the first day of January, or in any subsequent calendar year, shall be~~
8 ~~prorated with regard to the calendar year on a monthly basis.~~

9 Any amount paid as a filing fee by the organization pursuant to Section 3203 shall be
10 credited against the fees prescribed in the second paragraph of this Section.

11
12 **SEC. 3404. LICENSE.**

13 When any permit is issued under the provisions of Sections 3400 to 3408, the Chief of
14 Police shall cause said permit to be forwarded to the ~~o~~Office of the Treasurer and Tax Collector
15 for delivery to the permittee upon the payment of the license feetax.

16
17 **SEC. 3405. LICENSE FEETAX.**

18 Every holder of a permit as herein provided shall pay to the Tax Collector an annual
19 license fee. The license fee shall be paid annually on or before March 31, in accordance with the
20 provisions of Section 76.1 of the Business and Tax Regulations Code.

21 ~~License fees paid under the provisions of this Section shall not be prorated or refunded.~~

22 The licensee shall issue to each solicitor employed a badge of such wording, design
23 and material as the Chief of Police shall authorize. Said badge shall be worn on the person by
24 the solicitor for whom it was issued, in a conspicuous place for the public to see, at all times

1 when said person is engaged in taking such photographs or soliciting the same. It shall be
2 unlawful for any other person to wear or otherwise display said badge.

3
4 **SEC. 3425. LICENSE FEE.**

5 Every photographic solicitor shall pay a license fee for each such designated address
6 and, in addition thereto, a license fee for each and every person engaged, employed or hired
7 by said person, firm or corporation to solicit such business in any public street, alley, park or
8 other public place. The license fee shall be paid annually on or before March 31, in accordance with
9 the provisions of Section 76.1 of the Business and Tax Regulations Code.

10
11 **SEC. 3907. PRESENTATION OF PERMIT TO TAX COLLECTOR-LICENSE FEES.**

12 Upon the granting of a permit, as hereinabove provided, the Police Department shall
13 forward the permit to the Tax Collector, who shall furnish the permittee with the following:

14 (a) **Owner/Lessee:**

- 15 (1) Permit
16 (2) License
17 (3) Permit Plate

18 (b) **Operator:**

- 19 (1) Permit
20 (2) License
21 (3) Operator's Badge
22 (4) Identification Card

23 Each permittee is required to pay a license fee to the Tax Collector ~~as set forth in Section~~
24 ~~2.27 of this Code~~, and must pay the cost of such badge, card and plate as are issued. The
25

1 license fee shall be paid annually on or before March 31, in accordance with the provisions of Section
2 76.1 of the Business and Tax Regulations Code.

3
4 **SEC. 3908. PEDICAB LICENSE, PLATE, IDENTIFICATION CARD AND OPERATOR'S**
5 **BADGE.**

6 All pedicab licenses, metal plates and identification cards issued under the provisions
7 of Section 3907 of this Article shall date from the first day of ~~January~~ April of each year and
8 shall be issued for one year from the aforesaid date; provided, however, that when service is
9 first initiated, the license will be issued through the upcoming March 31 ~~for the remaining portion of~~
10 ~~the calendar year in which it is authorized~~ and only subsequent licenses will date from the first
11 day of ~~January~~ April for each succeeding year.

12 Section 6. Effective Date. This ordinance shall become effective 30 days from the
13 date of passage.


