

1 [Changing Official Sidewalk Width - Portions of Golden Gate Avenue, Polk Street, and
2 Redwood Alley]

3 **Ordinance: 1) amending Ordinance No. 1061 entitled "Regulating the Width of**
4 **Sidewalks" by adding thereto Section 1593 to change the official sidewalk width of a)**
5 **Golden Gate Avenue starting at the southwest corner of the intersection of Golden**
6 **Gate Avenue and Polk Street and continuing west 104 feet, b) Polk Street starting at the**
7 **southwest corner of the intersection of Golden Gate Avenue and Polk Street and**
8 **continuing south for 78 feet, and c) Redwood Alley starting at the northwest corner of**
9 **the intersection of Polk Street and Redwood Alley and continuing west for 173 feet; 2)**
10 **making environmental findings and findings pursuant to the General Plan and Planning**
11 **Code Section 101.1; and 3) requiring relocation, modification, or both of facilities**
12 **affected by the sidewalk width change.**

17 Be it ordained by the People of the City and County of San Francisco:

18 Section 1. The Board of Supervisors adopts as its own and incorporates by reference
19 herein as though fully set forth the Planning Department findings in its letter dated September
20 6, 2011. Said letter stated the actions contemplated herein are consistent with the General
21 Plan and in conformance with the Eight Priority Policies of Planning Code Section 101.1. A
22 copy of said letter is in the Clerk of the Board of Supervisors File No. 120138.

23 Section 2. In the abovementioned letter, the Planning Department also determined that
24 the actions contemplated in this Ordinance are in compliance with the California
25

1 Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said
2 determination is incorporated herein by reference.

3 Section 3. In accordance with the Department of Public Works' Order No. 179,914,
4 a copy of which is in the Clerk of the Board of Supervisors File No. 120138 and incorporated
5 herein by reference, Board of Supervisors Ordinance No.1061, entitled "Regulating the Width
6 of Sidewalks," a copy of which is in the Clerk of the Board of Supervisors Book of General
7 Ordinances, in effect May 11, 1910, is hereby amended by adding thereto a new section to
8 read as follows:


9 Section 1593. Changing the official sidewalk width of: a) Golden Gate Avenue starting at the
10 southwest corner of the intersection of Golden Gate Avenue and Polk Street and continuing west for
11 104 feet, b) Polk Street starting at the southwest corner of the intersection of Golden Gate Avenue and
12 Polk Street and continuing south 78 feet, and c) Redwood Alley starting at the northwest corner of the
13 intersection of Polk Street and Redwood Alley and continuing west 173 feet, as shown on Department
14 of Public Works drawing Q-20-702, of which is in the Clerk of the Board of Supervisors File No.
15 120138.


16 Section 4. The City and County of San Francisco Public Utilities Commission, as is
17 necessary as a result of this Ordinance, shall make arrangements with public utility
18 companies and City Departments for the relocation, and/or modification of any affected public
19 facilities. Any necessary relocation, modification, or both of such facilities shall be at the cost
20 of the owner of the utility.

21 Section 5. Effective Date. This Ordinance shall become effective 30 days from the
22 date of passage.




