

1 [Penalties for Late Payment of Parking Tickets]  
2 AMENDING PART II, CHAPTER XI, OF THE SAN FRANCISCO MUNICIPAL CODE  
3 (TRAFFIC CODE) BY ADDING SECTION 131 TO ARTICLE 7 OF THE CODE,  
4 ADOPTING A PENALTY SCHEDULE FOR THE LATE PAYMENT OF PARKING TICKETS  
5 AND PROVIDING THAT THE BOARD OF SUPERVISORS MAY BY RESOLUTION DECLARE  
6 PERIODS OF AMNESTY DURING WHICH LATE PAYMENT PENALTIES WOULD BE  
7 FORGIVEN UPON PROMPT PAYMENT OF THE UNDERLYING FINE.

8 Note: This entire section is new.

9 Be it ordained by the People of the City and County of San  
10 Francisco:

11 Section 1. Article 7 of the San Francisco Traffic Code is hereby  
12 amended by adding Section 131, to read as follows:

13 SEC. 131. LATE PAYMENT PENALTIES. (a) The penalty for failure  
14 to pay a parking penalty or contest the underlying citation by the  
15 first due date affixed to the notice of parking violation shall be  
16 \$12. The penalty for failure to pay a parking penalty or contest the  
17 underlying citation by the second due date affixed to the notice of  
18 parking violation shall be \$15. (b) By resolution, the Board of




