AMENDING ORDINANCE NO. 143-98 TO REDEFINE UNDERGROUND DISTRICT NO. 337 IN THE POTOMAC/WALLER AREA BY ADDING CERTAIN PROPERTY THERETO.

Be it ordained by the people of the City and County of San Francisco:

Section 1. In accordance with the provisions of Section 901, et seq. of Article 18, Chapter X, Part II of the San Francisco Municipal Code (Public Works Code), the Board of Supervisors does hereby create the following underground district:

Underground District No. 337

(Potomac/Waller)

Divisadero

District covering Waller Street from Steiner Street to ((Scott))-<u>Divisidero</u> Street, Potomac Street from Waller Street to dead end south, and Pierce Street from Waller Street to dead end south.

Section 2. The undergrounding of facilities within this underground district is in the general public interest in that said action will eliminate a heavy concentration of overhead wires.

Section 3. All work in connection with the undergrounding of facilities lying within this underground district and subject to the laws with reference to underground districts is to be completed in accordance with the Department of Public Works' program; provided, however, that said work shall be commenced at such time or according to such priority as the Department of Public Works has established.

Section 4. The Board hereby requests that the utility companies providing the undergrounding of facilities within this underground district pay for up to 100 feet of each underground service lateral occasioned by the undergrounding.
