The Board of Supervisors hereby implements the provisions of Amendment No. 1 to the 1998–2001 Memorandum of Understanding between the Teamsters Local 216 and the City and County of San Francisco to correct clerical omissions by: 1) adding MOU article III.F (Pre-scheduled Overtime), providing for a minimum period of time and rate of pay for certain overtime assignments; 2 adding MOU article III.O (Retirement), incorporating by reference any future rule changes by the City's retirement board regarding crediting of accrued sick leave for retirement purposes; and 3) adding MOU article III.G (Employee Tuition Reimbursement Program), providing for contributions to the Employee Tuition Reimbursement Fund. The amendment to the Memorandum of Understanding so implemented is on file in the office of the Board of Supervisors.
