




 11 arising from the December 11, 1995 Seacliff Incident, by payment of \$1,366,769.27 from U.S.
 12 Fire to the City. As consideration for this settlement, the City has agreed to fully release U.S.
 13 Fire from all claims arising from the December 11, 1995 Seacliff incident.




