7	Section 1. Article III, Chapter 50 of the San Francisco Administrative Code is hereby
8	amended by amending Section 50.22 to read as follows:
9	SEC. 50.22. MAXIMUM LOAN AMOUNT; FACTORS IN DETERMINING TERMS AND
10	CONDITIONS. The maximum amount of a loan under this Chapter shall be ((\$150,000))
11	<u>\$200,000</u> . The Director shall determine the terms and conditions of each loan, based upon
12	the following factors:
13	(a) Whether the arts organization owns the subject property or holds a longterm lease
14	the life of which exceeds the anticipated repayment period;
15	(b) The size, age, value and condition of the subject property;
16	(c) The nature and extent of all code and incipient code violations;
17	(d) The type of security to be given for the loan;
18	(e) The verifiable financial soundness of the arts organization and its ability to
19	complete the project for which the loan application is made;
20	(f) The degree to which an arts organization can demonstrate community intereest in
21	and support for its artistic programs; and
22	(g) Any other factors that the Director shall, by rule and regulation, establish.
