ORDINANCE NO. 326-99

1 [ESTABLISHMENT OF AIRPORT SPECIAL EVENT ACCOUNT]

2 AMENDING ARTICLE XIII, CHAPTER X OF THE SAN FRANCISCO ADMINISTRATIVE
3 CODE BY ADDING SECTION 10.114-3 TO ESTABLISH AN AIRPORT PROMOTION AND
4 EVENT ACCOUNT; ALLOW FOR THE ACCEPTANCE OF GIFTS BY THE AIRPORT
5 COMMISSION; AND AUTHORIZE THE AIRPORT COMMISSION TO EXPEND MONIES IN
6 ACCOUNT; THIS SECTION SHALL EXPIRE ON SEPTEMBER 30, 2001.

7 Note: This entire section is new.

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Article XIII, Chapter X of the San Francisco Administrative Code is hereby
10 amended by adding Section 10.114-3, to read as follows:

11 **SEC. 10.114-3. AIRPORT PROMOTION AND EVENT ACCOUNT:**
12 **ESTABLISHMENT OF ACCOUNT; ACCEPTANCE OF GIFTS; AUTHORIZATION TO**
13 **EXPEND MONIES IN ACCOUNT; PROVIDE FOR DEPOSIT OF UNEXPENDED MONIES IN**
14 **CITY'S GENERAL FUND; REPORTING REQUIREMENTS; SUNSET CLAUSE.**

15 (a) **Establishment of Account.** There is hereby established a special account in the
16 records of the City and County of San Francisco to be known as the Airport Promotion and
17 Special Event Account for the purpose of receiving all donations of money, property and
18 personal services which may be offered to the City and County of San Francisco through the
19 Airport for the use and benefit of the Airport Promotion and Event Account.

21 (b) **Acceptance of Gifts.** All donations of money, property and personal services
22 which may from time to time be offered to the City and County of San Francisco for use and
23 benefit of the Airport Promotion and Event Account are hereby accepted for such purpose.




