13 WHEREAS, The City Planning Department has verified that the area is properly zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license application be approved; now,

16 RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code,  
17 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that  
18 the transfer of a Type 17 beer and wine wholesaler license from 848 Ashbury Street to 1186 Folsom Street, issuance  
19 of a Type 9 beer and wine importer license, and a conditional Type 20 off-sale beer and wine alcoholic beverage  
20 control license for Richard Bruno for VINUM Cellars, will serve the public convenience and necessity of the people  
21 of the City and County of San Francisco.


