

1 [Contract Modification; Trolley Bus Contract]

2 APPROVING CONTRACT MODIFICATION NO. 3 TO TROLLEY PROCUREMENT
3 CONTRACT NO. 888 WITH ELECTRIC TRANSIT INCORPORATED IN AN AMOUNT NOT
4 TO EXCEED \$13,978,835.99, FOR 23 OPTION TROLLEY COACHES (20 STANDARD, 3
5 ARTICULATED), FOR SPARE PARTS, AND FOR ADDITIONAL, IMPROVED
6 COMPONENTS, FOR A TOTAL CONTRACT AMOUNT NOT TO EXCEED \$187,568,318.89.

7 WHEREAS, In June, 1997, after a competitive negotiated procurement, the City
8 executed Procurement Contract No. 888 with Electric Transit Incorporated (ETI), for the
9 purchase of 30 articulated trolley coaches, with an option for up to 15 additional articulated
10 trolley coaches and 220 standard trolley coaches, with an option for up to 25 additional
11 standard trolley coaches, associated spare parts, training, manuals, and diagnostic test
12 equipment, for an original contract amount of \$168,752,888 ("Agreement"); and,

13 WHEREAS, Pursuant to Public Transit Commission (PTC) Resolution No. 98-074 and
14 Board of Supervisors Resolution No. 885-97, the City approved Contract Modification No. 1 to
15 Agreement, for the purchase of additional and improved components and associated spare
16 parts (exterior door push-button, the electric odometer system, the Kiepe current collection
17 system, a central recording station and remote mirrors), increasing the amount of the contract
18 by \$3,844,455.90, for a contract amount not to exceed \$172,597,342.90; and

19 WHEREAS, Pursuant to PTC Resolution 98-096 and Board of Supervisors Resolution
20 No. 1020-98, the City approved Contract Modification No. 2 to Agreement, for the purchase of
21 improved components and associated spare parts (interior information signs, communication
22 wiring equipment (compliant with SAE J1708 standards), curbside turn lights for articulated
23 trolley coaches, hands-free public announcement (PA) microphones, and operator's side
24 window shades), increasing the amount of contract by \$992,140, for a contract amount not to
25 exceed \$173,589,482.90; and

1 WHEREAS, The PTC desires to exercise a contract option to purchase 23 additional
2 coaches and to also purchase improved components and associated spare parts, including
3 improved floor covering; provisions for signal prioritization equipment to be installed on 33
4 articulated coaches, Proof of Payment (POP) button bezels, LED turn signal lights, a paint
5 scheme change with decals, upgrades to leather/vinyl for operator's seats, transfer box
6 deletion, Mobile-Tech wheelchair wheel clamps, and additional training hours for Municipal
7 Railway personnel; and,

8 WHEREAS, On January 18, 2000, pursuant to Resolution No. 00-008, and
9 with the concurrence of the Purchaser, the PTC approved Contract Modification No. 3,
10 increased the project budget, and commended the matter to this Board for approval; and,

11 WHEREAS, Funding for Contract Modification No. 3 in an amount not to exceed
12 \$13,978,835.99, and total contract price not to exceed \$187,568,318.89, will come from
13 federal, state, and local available funds in the contract budget; now, therefore, be it

14 RESOLVED, That the Board of Supervisors hereby approves Modification No. 3 to
15 Trolley Procurement Contract No. 888 with Electric Transit Incorporated in an amount not to
16 exceed \$13,978,835.99, for the purchase of 23 option trolley coaches (20 standard, 3
17 articulated), for spare parts, and for additional, improved components, for a total contract price
18 not to exceed \$187,568,318.89.


