2 REVISING THE REGULAR MEETING SCHEDULE OF THE BOARD OF SUPERVISORS BY  
3 CANCELING THE JULY 3, 2000, NOVEMBER 27, 2000, AND DECEMBER 26, 2000  
4 MEETINGS AND BY CANCELING ALL BOARD AND COMMITTEE MEETINGS FROM  
5 AUGUST 29 THROUGH SEPTEMBER 17, 2000.

7 WHEREAS, Pursuant to the Rules of Order of the Board of Supervisors that the Board  
8 shall not meet during the week after Thanksgiving, between December 24 and December 31,  
9 inclusive, nor on any Monday if the following day is a holiday; and

10 WHEREAS, The July 3, 2000 regularly scheduled meeting of the Board of Supervisors  
11 falls on a Monday preceding the Independence Day holiday on July 4, 2000, and the  
12 November 27, 2000 regularly scheduled meeting of the Board of Supervisors falls in the week  
13 after Thanksgiving, and the December 25, 2000 regularly scheduled meeting of the Board of  
14 Supervisors falls on a holiday and thus is moved to the next regular business day, December  
15 26, 2000, which falls between December 24 and December 31; and,

16 WHEREAS, In order to establish a stated period of time during which members of the  
17 Board of Supervisors may plan to be away from the Board without missing any Board or  
18 committee meetings or other important public business, and without causing difficulties in  
19 achieving a quorum, the Board of Supervisors now wishes to follow the tradition established  
20 by many other sitting legislative bodies in the United States and provide for a scheduled  
21 recess period, and selects the period from August 29 through September 17, 2000 for this  
22 recess; now, therefore, be it

23 RESOLVED, That the meetings of the Board of Supervisors scheduled for July 3,  
24 2000, November 27, 2000, and December 26, 2000 are canceled; and be it




