14 services in the new library to enable public access to the rich  
15 online resources available through the library databases and the  
16 Internet; and,

17 WHEREAS, Funds are also needed to augment and enhance the opening  
18 collection of books and materials for the new branch; and,

19 WHEREAS, The Grand Opening of the Ocean View Library is scheduled  
20 for June 2000 and it is incumbent upon the library to have all  
21 systems operational by that opening date; now, therefore, be it

22 RESOLVED, That the San Francisco Public Library be authorized to  
23 accept and expend a gift of \$31,092 from the Friends and Foundation  
24 of the San Francisco Public Library; and be it




