[Accept-Expend Regional Grant]

AUTHORIZING THE DIRECTOR OF ADMINISTRATIVE SERVICES TO ACCEPT Retroactively AND EXPEND \$1,986,000 FROM THE BAY AREA AIR QUALITY MANAGEMENT DISTRICT'S TRANSPORTATION FUND FOR CLEAN AIR FOR VARIOUS PROJECTS INCLUDING ONE TO BE DEVELOPED BY THE SAN FRANCISCO MUNICIPAL RAILWAY, AND AUTHORIZING THE DIRECTORS OF ADMINISTRATIVE SERVICES AND SAN FRANCISCO MUNICIPAL RAILWAY TO EXECUTE AGREEMENTS WITH THE BAY AREA AIR QUALITY MANAGEMENT DISTRICT, WHEREBY, THE CITY WOULD INDEMNIFY THE DISTRICT FROM CLAIMS RESULTING FROM THE CITY'S PERFORMANCE OF SAID AGREEMENTS.

WHEREAS, The Bay Area Air Quality Management District ("District") has approved \$1,986,000 from the Transportation Fund for Clean Air, for the Department of Administrative Services and San Francisco Municipal Railway to implement the following clean air vehicle projects:

1) SF Municipal Railway Alternative Fuel Bus Demonstration Project-To fund \$1,006,000 for the development of 2 compressed natural gas (CNG) buses and 2 hybrid electric/diesel buses.

2) Department of Administrative Services/Norcal Transfer Truck Project-To fund the incremental costs of 14 liquefied natural gas transfer trucks in the amount of \$980,000.

WHEREAS, the District requires that the City enter into funding agreements in order to receive the funds to be used for these projects; and

WHEREAS, the District requires that the City shall indemnify and hold harmless the Air District, its officers, employees, agents, representatives, and successors-in-interest against any and all claims, suits, or actions resulting from the performance by the City of its duties under the agreements; and
