9 6.22, is required to fix the highest general prevailing rate of wages, including wages paid for  
10 holiday and overtime work, for various crafts and kinds of labor as paid for similar work in  
11 private employment in the City and County of San Francisco; and

12 WHEREAS, The Civil Service Commission at its meeting of December 6, 1999,  
13 certified and forwarded to the Board of Supervisors data as to the highest general prevailing  
14 rate of wages, including wages paid for holiday and overtime work, for various crafts and  
15 kinds of labor as paid for similar work in private employment in the City and County of San  
16 Francisco; now, therefore, be it

18 RESOLVED, The Board of Supervisors hereby adopts the data certified by the Civil  
19 Service Commission at its meeting of December 6, 1999; and be it

21 FURTHER RESOLVED, The Board of Supervisors hereby fixes the highest general  
22 prevailing rate of wages, including wages paid for holiday and overtime work, for various  
23 crafts and kinds of labor as paid for similar work in private employment in the City and County


