2 APPOINTING SURESH PATEL AND DEBORAH RAUCHER, WITH WAIVER OF
3 RESIDENCY, FOR ONE YEAR TERMS ENDING, OCTOBER 8, 2000, TO THE SRO HOTEL
4 SAFETY AND STABILIZATION TASK FORCE.

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated persons to serve as members of the SRO
8 Hotel Safety and Stabilization Task Force, pursuant to the provisions of Resolution 868-99,
9 for the term specified:

10 Suresh Patel, new appointment, (Seat No. 10, must be SRO Hotel Owner or Manager),
11 new one-year term ending October 8, 2000;

12 Deborah Raucher, new appointment, (Seat No. 15, must be Tenderloin SRO Tenant
13 or representative from a community based organization with a significant focus on educating
14 SRO tenants about the risk of fire), new one-year term ending October 8, 2000.

15 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 16 1. The membership of the SRO Hotel Safety and Stabilization Task Force has a goal
17 to be representative of the diversity of the City and County of San Francisco.
- 18 2. Applicant Deborah Raucher, a new appointee, who is not a resident of San
19 Francisco, is a person with experience that uniquely qualifies him/her to serve on
20 the SRO Hotel Safety and Stabilization Task Force.
- 21 3. The SRO Hotel Safety and Stabilization Task Force has attempted to fill the
22 position, for which Deborah Raucher was nominated, with an individual who is a
23 City resident and who has the specific experience, skills, and qualifications, but has
24 been unable to do so at this time. The Rules Committee has certified that

FURTHER RESOLVED, That the Board of Supervisors waives the residency requirement for Deborah Raucher, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.


