AUTHORIZING EXPENDITURE OF FUNDS FOR EMERGENCY REPAIR OF CORROSION IN SAN JOAQUIN PIPELINE NO. 3 OF THE HETCH HETCHY AQUEDUCT.

WHEREAS, examination and materials testing on San Joaquin
Pipeline No. 3 of the Hetch Hetchy Aqueduct has revealed serious
corrosion that could lead to a pipeline rupture; and,

WHEREAS, such a pipeline rupture could lead to a pipeline collapse endangering adjacent, parallel pipelines and the foundation of the Hetch Hetchy Moccasin-Newark Transmission Line;

WHEREAS, such a pipeline rupture will threaten the health and safety of the citizens of San Francisco and other Bay Area communities due to a massive reduction in water supply for an indeterminate period of time; and,

WHEREAS, on November 19, 1999, the President of the Public Utilities Commission, in accordance with <u>San Francisco</u>

<u>Administrative Code</u> Article IV, §6.60, declared the existence of an emergency condition requiring immediate repairs to San

Joaquin Pipeline No. 3 of the Hetch Hetchy Aqueduct to prevent or mitigate loss of, or damage to life, health, property or essential public services; and,

WHEREAS, by Resolution 00-0079 of March 14, 2000, the Public Utilities Commission ratified the November 19, 1999

Declaration of Emergency made by the President of the Commission

and requested the Board of Supervisors approve the expenditure of four million two hundred ten thousand dollars (\$4,210,000.00) to repair San Joaquin Pipeline No. 3; and

WHEREAS, funding for the repairs is currently available in Hetch Hetchy Project No. CUH762 San Joaquin Pipeline Repair; now, therefore, be it

RESOLVED, that the Board of Supervisors approves the emergency expenditure of four million two hundred ten thousand dollars (\$4,210,000.00) for repair of San Joaquin Pipeline No. 3 of the Hetch Hetchy Aqueduct.
