3 AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, POPULATION HEALTH AND  
4 PREVENTION, COMMUNITY MENTAL HEALTH SERVICES, TO ENTER INTO A  
5 SUBCONTRACT IN THE AMOUNT OF \$3,285.31 WITH THE UNIVERSITY OF CALIFORNIA  
6 (SAN FRANCISCO), THE PRIMARY CONTRACTOR, TO PROVIDE DATA AND  
7 CONSULTATION FOR A STUDY OF THE CONSEQUENCES OF COMORBID DRUG ABUSE AND  
8 MENTAL DISORDERS, WHICH INCLUDES A RIGHTS IN DATA CLAUSE AND DOES NOT  
9 INCLUDE INTELLECTUAL PROPERTY INDEMNIFICATION AND FALSE CLAIMS CLAUSES;  
10 RETROACTIVE TO SEPTEMBER 1, 1999.

11 WHEREAS, The University of California (San Francisco) has received funds from the  
12 Department of Health and Human Services (DHHS) for a project entitled “Consequences of Comorbid  
13 Drug Abuse and Mental Disorders”; and,

14 WHEREAS, The University of California (San Francisco) as the primary contractor, has  
15 requested that the Department of Public Health, Community Mental Health Services, enter into a  
16 subcontract to participate in this project; and,

17 WHEREAS, The University of California (San Francisco) has agreed to reimburse the  
18 Department of Public Health, Community Mental Health Services in the amount of \$3,285.31 under the  
19 terms of this subcontract; and

20 WHEREAS, The subcontract specifies that the Department of Public Health is to provide data  
21 and consultation deemed necessary to meet the reporting requirements of the DHHS Granting Agency  
22 during the term of the subcontract; and

23 WHEREAS, As a condition of receiving the funds, University of California (San Francisco)  
24 requires the City to enter into an agreement (the “Agreement”), a copy of which is on file with the Clerk  
25 of the Board of Supervisors in File No. 000776 ; and,

WHEREAS, The Agreement contains a certain provision described below, which requires the  
approval of the Board of Supervisors; and,

WHEREAS, The Agreement does not contain certain provisions described below, which are  
required under the Administrative Code unless waived by the Board of Supervisors; and

1           WHEREAS, The grant budget includes provision for indirect costs of \$156.44; now, therefore,  
2 be it

3           RESOLVED, That the Department of Public Health is hereby authorized to enter into a  
4 subcontract in the amount of \$3,285.31 with the University of California (San Francisco), the primary  
5 contractor, for provision of data and consultation during the period covered by this Agreement;  
6 retroactive to September 1, 1999; and, be it

7           FURTHER RESOLVED, That the Director of Health is authorized to enter into the Agreement  
8 on behalf of the City; and, be it


9           FURTHER RESOLVED, That the Board of Supervisors hereby approves the provision in the  
10 Agreement pursuant to which the City agrees to grant a royalty-free, nonexclusive, and irrevocable  
11 license for the use of data developed under the subcontract; and, be it

12           FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement  
13 contained in Section 21.21 of the Administrative Code that the Agreement include an indemnification of  
14 the City by the University of California for the infringement of patent rights, copyright, trademark, and  
15 other intellectual property rights; and, be it

16           FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement that the  
17 Agreement include a paragraph reciting the false claim provisions contained in Section 21.35 of the  
18 Administrative Code; and, be it

19           FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Health to  
20 enter into similar agreements with the University of California (San Francisco) if the subcontract recurs  
21 or is renewed.


