

1 [In-Kind Donation]

2 AUTHORIZING THE DEPARTMENT OF THE ENVIRONMENT TO ACCEPT IN -KIND
3 SERVICES IN THE AMOUNT OF \$60,000 FROM LAWRENCE LIVERMORE NATIONAL
4 LABORATORY (LLNL).

5 WHEREAS, The City and County of San Francisco passed a resolution on March 9,
6 1999 "Establishing Dioxin Pollution as a high priority for immediate action for the City and
7 County of San Francisco in order to restore water, air and total environmental quality"; and,

8 WHEREAS, Contaminants have been identified in the East Harbor of the Marina
9 District, better known as Gas House Cove; and,

10 WHEREAS, Lawrence Livermore National Laboratory (LLNL) is a U.S. Department of
11 Energy national laboratory managed by the University of California; and,

12 WHEREAS, LLNL's mission is to apply science and technology in the national interest,
13 with a focus on global security, global ecology, and bio-science; and,

14 WHEREAS, LLNL's mission is dynamic and has changed over the years to meet new
15 national needs ; and,

16 WHEREAS, The Director's Office of Science and Technology at LLNL has a "Work in
17 the Public Interest Fund" to assist local governments with scientific and technical issues that
18 have benefits to the local governments and communities ; and,

19 WHEREAS, LLNL has offered assistance to the City and County of San Francisco on
20 source identification, sampling methods, reduction, prevention, economic consequences,
21 elimination strategies and methods for assessing potential health effects/impacts of toxic
22 substances; now, therefore, be it

23 RESOLVED, That the Board of Supervisors does hereby authorize the Department of
24 the Environment to accept in-kind services, valued at \$60,000, from LLNL to (1) assist the
25 Department of the Environment with it's goals of reducing dioxin emissions in the Bay Area

1 and (2) consult and perform laboratory services with respect to contamination at Gashouse
2 Cove, including reviewing and recommending strategies to identify possible sources of
3 contamination.




