URGING THE SAN FRANCISCO DEPARTMENT OF PARKING AND TRAFFIC TO REPLACE THE SPEED BUMPS ON APPLETON AVENUE BETWEEN PATTON AND HOLLY PARK AND TO DESIGNATE THE CURB IN FRONT OF THE ELEMENTARY SCHOOL LOCATED ON 155 APPLETON AS A PASSENGER LOADING ZONE AS WELL AS TO SEND GET WELL WISHES TO SIX YEAR OLD JONATHAN MORA.

WHEREAS, On May 24, 2000, Jonathan Mora, a six year old student at Junipero Serra Elementary School, was struck by a car while crossing Appleton Avenue in front of the school; and,

WHEREAS, Despite being dragged by the car for a few feet and having his head run over by car as it backed up, Jonathan survived the mishap and is stable but critical condition San Francisco General Hospital;

WHEREAS, Since the repaving of Appleton Avenue, parents, teachers and neighbors have long complained about the frequent speeding of cars along the streets and have long wanted the City to replace the speed bumps; and

WHEREAS, In addition, parents and teachers have been wanting the City to designate the curb in front of the school at 155 Appleton Avenue as passenger loading zone from the hours of 7:00AM to 6:00PM; and,

WHEREAS, The replacement of speed bumps on Appleton as well as designating a passenger loading zone in front of the school would greatly contribute the safety of school children, parents and teachers and would discourage speeding along Appleton; now therefore be it
