

1 [Parking for Jurors]

2 URGING THE PUBLIC UTILITIES COMMISSION TO ACT WITH ALL DUE HASTE IN
3 EXPANDING PARKING OPPORTUNITIES AT 5TH AND BRANNAN STREETS, WITH A
4 PORTION OF THIS PARKING SPECIFICALLY DESIGNATED FOR JURORS.

5 WHEREAS, The City and County of San Francisco supports rewarding its citizens for public
6 service, including jury duty; and,

7 WHEREAS, San Mateo County, which has a population roughly similar to that of San
8 Francisco, boasts of a 60% rate of jurors showing up for service when called, as contrasted with San
9 Francisco's approximately 25 - 30% rate of jurors showing up for service; and,

10 WHEREAS, In part, San Mateo County credits its high percentage of jurors who show up to
11 the availability of free juror parking; and,

12 WHEREAS, In San Francisco, parking and transportation options are often problematic for
13 jurors trying to access the downtown court rooms; and,

14 WHEREAS, The Department of Parking and Traffic has been working with the Public
15 Utilities Commission in creating a surface lot for 450 spaces where 150 currently exists at 5th and
16 Brannan Streets; and,

17 WHEREAS, A portion of these spaces could be specifically reserved for jurors; now, therefore,
18 be it

19 RESOLVED, That the San Francisco Board of Supervisors does hereby urge the Public Utilities
20 Commission to act with all due haste in expanding parking opportunities at 5th and Brannan Streets with
21 a portion of this parking specifically designated for jurors; and, be it

22 FURTHER RESOLVED, That the San Francisco Board of Supervisors does hereby ask that
23 copies of this resolution be sent to the Department and the Commission of Parking and Traffic and to
24 the Public Utilities Commission.




