RESOLUTION URGING THE SAN FRANCISCO PUBLIC UTILITIES COMMISSION AND THE PACIFIC GAS AND ELECTRIC COMPANY TO PLACE STICKERS WITH THE CONTACT INFORMATION FOR BULB REPLACEMENT ON STREETLIGHT AS MAINTENANCE CREWS PERFORM SERVICE AND ON THEIR WEB SITE.

WHEREAS, The San Francisco Bureau of Light, Heat and Power maintains about one half of the approximately 40,0000 streetlights throughout the city and Pacific Gas and Electric Company (PG&E) owns and provides maintenance service under contract to the City on the other half of the streetlights; and,

WHEREAS, Neither entity routinely surveys their streetlights for outages and normally bulbs are replaced when citizens report outages; and,

WHEREAS, In response to an inquiry on the feasibility of indicating on streetlight, by stencil or other means, the appropriate telephone number of who and where to call when a streetlight needs service, the PUC stated that stenciling or tagging streetlight poles presented some major obstacles; and,

WHEREAS, In response to that same inquiry the PUC reported that placing a sticker with the appropriate information on streetlight poles with suitable surfaces as maintenance crews perform service; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco urges the San Francisco Public Utilities Commission

SUPERVISOR, BECERRIL, BROWN KATZ BOARD OF SUPERVISORS to place stickers with the contact information for bulb replacement on streetlight poles as maintenance crews perform service and on their web site; and be it

FURTHER RESOLVED, That the Board of Supervisors of the City and County of San Francisco urges the Pacific Gas and Electric Company to place stickers with the contact information for bulb replacement on streetlight poles as maintenance crews perform service and on their web site, and that a copy of this resolution be forwarded to these agencies.
